Team Member Spotlight: Chair, Robert Rigg

Tell us about yourself and the work you do at Washington State University?

I am the SEVIS Coordinator and PDSO at WSU - I am the university's lead F-1 and J-1 student regulatory expert and I manage WSU's SEVIS compliance and the software we use as part of maintaining compliance. I have been in this role for 12 years now, expanding my scope over time.

What excites you the most about your role?

Many things - meeting students from about 100 different countries, regulations and technology that are constantly changing which keeps me learning and adapting/updating constantly, having one foot in the tech world and the other in the advising regulatory word.... Are three that come to mind.



Why did you decide to join the NAFSA Region I team?

NAFSA has been a big part of my learning and professional development over the years and it was time for me to pay that forward - also it is a great experience for me as it pushes my me to do new things that are outside of my day to day duties at work.

Can you tell us about your participation on the NAFSA Region I team?

I joined the region 1 team as the KCISSS rep a few years ago, but have been presenting sessions and CEP workshops for many years now. Being asked to serve in the chair stream was a great honor for me, and I will do the very best I can in this position.

What are some ways we can encourage more people to get involved in NAFSA Region I activities?

One of my main goals for my chair year is to get more people involved in helping the team with planning and activities over the year - so many people offer to volunteer or be part of the team, but the team has a limited number of positions. Having more volunteers be on the team's committees and mentor with current team members can have the great effect of getting more individuals excited about NAFSA, attend more events, and become future leaders themselves. Also this year we are giving a big push to more robust communication out to the region, improving our presence on social media, enhance our newsletter, and find more ways to have events happen throughout the year other than just at the annual regional conference.

How did you end up in the field of International Education?

This would be a very long story indeed - let me keep it short and say that it was not something I had ever aspired to, although I have always been very passionate about cultural understanding and making the word a more peaceful and respectful place. It was my technical skills that brought me into this field (having been self-employed for most of my life), coming aboard right as SEVIS was created and new technology was needed to help with SEVIS reporting and compliance. I started as a consultant with my current office, being hired to examine and give advice on their current practices and systems... and as I was finishing up my contract I was encouraged to apply for the brand new SEVIS Coordinator Position.... It took some persuading as I enjoyed being self-employed, but I took the job and here I am 12 years later still loving what I do.

What do you most look forward to every day when you are heading to work?

The challenges and fast pace of the office - never a dull moment and definitely never a time where I do not feel like I am doing something important and needed. And that I know every day I am doing something that helps students, and in some small way am helping to make the world a better place by helping others have a good intercultural experience.

What is your favorite thing to do outside of work?

Spend time with family (have two daughters age 11 and 17), play bass guitar in a local band, home brewing and home roasting coffee.

We are saddened to share that a beloved colleague in our field has passed. Cecile Mitchell (1938 - 2015)passed peacefully at home in Anchorage, Alaska, on Sept. 24, 2015, surrounded by her family and her best friend, Henny Newcomb of Phoenix, Ariz. Born on June 29, 1938, in Chewalla, Tenn., Cecile was the oldest daughter of Mae and Cletus York. SEVP Publishes Stakeholder Issues Response Report

In response to feedback and suggestions receiving during the NAFSA 2016 Annual Conference & Expo open meeting "Discussion of Trends and Issues" with SEVP Director Lou Farrell," the Student and Exchange Visitor Program (SEVP) issues a *Stakeholder Issues Response Report*. The report addresses 15 key issues for students, schools, and Designated School Officials, including Form I-17 update processing times,

nontraditional programs, and the temporary absence process.

NAFSA to Host Government Connection Event on J-1 Exchange Visitor Program

On Thursday, February 4, 2016, at 3:00pm (EST), NAFSA will host a Government Connection event on the <u>J-1 Exchange Visitor Program: What, When, Why, and How to Report Incidents to the DOS</u>. During this free live event, Mark Howard from the Department of State's Office of Private Sector Exchange Administration (OPA) will provide additional guidance on reporting J-1 exchange visitor program incidents to the department.

Extension of stay of the STEM OPT Vacatur

On January 23, 2016, the District Court granted DHS' motion to extend the stay of the vacatur of the STEM OPT rule from February 12, 2016 until May 10, 2016. Read the court's order and memorandum opinion explaining why the court granted the extension.

USCIS & IRS Sends Out Scam Warning: Keep Your Students and Scholars Informed

USCIS and the IRS recently issued a scam warning notifying stakeholders of con artists who pose as IRS officers and aggressively threaten their targets to get them to immediately pay a fine or fee. These con artists also often pose as "immigration officers," FBI agents and other government officials. At Portland State University there have been a number of students and scholars who have received these scam calls. The students reported that the scammers were very aggressive, persistent (even called back repeatedly) and sometimes frightening. Anyone who receives such a call should just hang up and report it to the Treasury Inspector General for Tax Administration by calling 800-366-4484 or visiting www.tigta.gov. Also, report it to the Federal Trade Commission at www.tigta.gov/complaint.
