# International Student and Scholar Services (ISSS) Knowledge Community Updates

Meet your Regulatory Team: A team of three volunteers stands ready to assist you with your sticky cases and tricky questions. The role of the Regulatory Ombuds includes providing case intervention with the USCIS service centers (through IssueNet Get Liaison Help), regulatory problemsolving and engaging in practice advocacy. We also report trends and provide information to the region regarding interpretation of agency practices as well as encourage reporting by you to NAFSA of strange or unusual events you are seeing with respect to immigration processing, whether at the service centers, consular affairs posts or U.S. ports of entry through IssueNet Report an Issue.

The role of the International Students and Scholar Services (KC-ISSS)

Regional Liaison is to serve as a resource for you to seek advice about day-to-day practice issues and/or questions, which may include "how do I" or "when do I". The KCISSS RL provides information on best practices especially as they relate to developing issues.

All three work together to provide assistance to student and scholar advisers within the Region.

Machelle Allman is the NAFSA Region I Regulatory Ombud for student issues, and works at the University of Washington. She has been a RegBud for 3 years. If you have Forms I-765 or I-539 stuck with USCIS, or if you get crazy RFE's, contact her through Issue Net "Get Liaison Help" or by email.

Carol Holz is the Regulatory Ombud for scholar issues and works at the University of Alaska Fairbanks. She has been a RegBud for 4 years. If you have forms stuck with USCIS relating to scholars (I-129, I-140, etc.) or receive unusual RFEs for pending cases, contact her through Issue Net "Get Liaison Help" or <a href="by-email">by-email</a>.

Catherine Creason is the NAFSA Region I KCISSS Regional Liaison and works at South Seattle College. This is her first year as the KCISSS RL and she has served on the Region 1 team for 3 years in other positions. If you have any "how do I" or "when do I" questions, contact her by email.
