Suggestions for 765 Filers

3 Common problems:

Not correctly notating (c)(3)(B) on question #16 for post-comp OPT
 I-20 not matching SEVIS, especially w/ regard to program end date
 Name, Country of birth/citizenship errors

Process to Correct EADs with applicant error

Applicant must file NEW I-765 with proper fee and supporting documentation
 Include statement addressing the error and the incorrect EA
 Practice NOTE to DSO's: Review your student's application before it is sent out

EAD Mailing Issues

If EAD has been mailed out, not received AND not returned to TSC:

Applicant must file new I-765 with proper fee and supporting documentation

Practice Note to DSO's: Use your office address on the I-765

EAD Mailing Issues (cont'd) If EAD has been mailed out, not received AND returned to TSC:

Applicant must notify TSC with correct address.

Practice Note to DSO's: Use your office address on the I-765

Will the 765 be processed?

If an applicant who filed and received 6 months of OPT (e.g. 06/01 – 11/30) wants to file for the remaining 6 months (e.g. 12/01- 05/31)?

If an applicant completes a certificate program?

Cap Gap Issues

How can USCIS help?
OPT in SEVIS record is shortened to 10/1 but student doesn't want H1B

OPT in SEVIS record is extended to 10/1, student now wants STEM instead of H1B

Note: Cancelled check copy will normally contain receipt number

I-140/I-485

Common problem for I-140 petitions
Not all of the initial evidence is submitted at the time of filing
Quality review should be accomplished to ensure that all required evidence is included in the petition

Suggestions for Outstanding Professor/Researcher Applications

- Include a cover letter that provides a roadmap of documents submitted
 Place the cover letter right underneath form I-140
- Tab supporting documents according to the cover letter

Suggestions for Outstanding Professor/Researcher Applications Cont'd

Reference letters should provide specific detail on the foreign national's accomplishments.

 For example in documenting the scholar's contribution to the academic field state not only what their contribution was but how they contributed and why that contribution is important.

Suggestions for Outstanding Professor/Researcher Applications Cont'd

If the scholar received awards, give the name of the award as well as the criteria for which the award is determined.

I-140s/ I-485s and Related Forms Inquiries

- Contact the National Customer Service Center; NCSC will forward the inquiries to the service center for action
 - If inquiry relates to non receipt of a receipt notice, give the NCSC the name and date of birth of the scholar.
 - Recommendation: get a copy of the canceled fee check as the receipt number is normally written on the processed check.

Process Organization

I-140s, I-485s, and related forms are processed in receipt date order (FIFO)
 However, other factors such as FBI name checks, fingerprints, security hits, and availability of visa numbers, affect the processing of a case.

I-140 Case Transfers

Are some I-140 cases still being transferred to NSC? What kind of cases are transferred? **Electronically filed cases?** If an applicant whose I-140 was transferred to NSC wants to file form I-485 concurrently, should they send the I-485 to TSC or NSC?
