Conference Workshops

Foreign Educational Credentials Analysis

Monday, October 25, 8:00 am to 5:00 pm and Tuesday, October 26, 8:00 to noon

Audience: Admissions professionals and recruiters with less than 3 years of experience in foreign academic credential evaluation and placement

This 12-hour workshop provides basic training in foreign credentials evaluation and placement for individuals from universities and colleges. Topics covered include: information needed to evaluate credentials, how to develop a resource library and support base and understanding the credit and grade conversion process. Note: Participants should bring a calculator.

Workshop Objectives:

- Recognize and identify status/legitimacy of institution
 - Understand basic methodology and benchmarking credentials
 - Apply basic methodology and benchmarking to credentials
 - Become familiar with available resources and create a resource library
 - Convert grades; convert credits from credit-based, hours-based, marks-based and outcome-based credentials
 - Calculate grade point averages

Fundamentals of Short-Term Education Abroad Programming

Monday, October 25, 1:00 pm to 5:00 pm and Tuesday, October 26, 8:00 to noon

Audience: Professionals new to education abroad and/or short-term programs.

This workshop provides a comprehensive foundation in key aspects of short-term study abroad programming. With an outcomes-based perspective, participants will explore “campus cultures” so they can identify and best use internal support systems to design and deliver institution-sponsored short-term programs. Explore a variety of short term program models. Participants will learn the basics of financial management. Tools used in designing successful programs will be shared and participants will learn how to implement action plans, carry out assessment and prepare participants for their time away from campus. This workshop is highly interactive and is designed for professionals new to education abroad and/or short-term programs.

Workshop Objectives

- Develop a clear understanding of ways to use internal support systems in designing faculty-led short-term programs
- Develop an understanding of short-term program models and be able to determine which of those models best fit the participants’ home institution
- Develop an understanding of financial management of short-term programs
- Develop an awareness of the logistical process for operating short-term programs, such as timelines, budgeting, on-site arrangements and student recruitment
- Learn strategies to responsibly prepare faculty, staff, and students for the short-term experience
- Appreciate why assessment is important and to understand the fundamentals of designing an effective assessment plan

Conference Workshops

F-I Student Advising for Beginners

Monday, October 25, 1:00 pm to 5:00 pm and Tuesday, October 26, 8:00 to noon

Audience: F-I student advisers with less than one year experience

This introductory workshop provides participants with hands-on opportunities to learn how to handle the most common requests made of new Designated School Officials (DSO). Participants will develop skills to help them interpret the common requests F-I students have during the course of their program, research the regulations and other resources that help inform and define the work of the DSO and determine the best course of action in each case. The workshop will apply these skills to requests such as: issuing I-20s, maintaining status, employment, practical training, travel and reentry and program extensions.

Workshop Objectives:

Participants will be able to:

- Interpret student requests and accurately advise them on how to maintain their F-I status
 - Make informed decisions using a process that will incorporate the myriad influences affecting the decision
 - Comply with legal and institutional reporting requirements
 - Educate key parties on important matters involving international students

F-I Student Advising - Intermediate

Monday, October 25, 1:00 pm to 5:00 pm and Tuesday, October 26, 8:00 to noon

Audience: Designated School Officials with at least 15 months experience, who have participated in the F-I Student Advising for Beginners workshop, or have received training equivalent to F-I Student Advising for Beginners.

This intermediate-level workshop is designed for Designated School Officials who understand the processes of F-I student advising and are ready to tackle some of the more complex, or "gray," situations. Participants will discuss a range of case studies on the topics of DSO Responsibilities, Maintenance of Status, Travel, Transfers, Employment, Change of Status and Reinstatement. By addressing these case studies, participants will learn how to advise students when regulations and guidance do not give a clear answer to their situation. Participants should have been in the field for at least 15 months, have participated in the F-I Student Advising for Beginners workshop or have received training equivalent to F-I Student Advising for Beginners. If you are new to the field, in order to receive the maximum benefit from this training it is recommended that you allow for some time to apply the skills introduced in the F-I Student Advising for Beginners workshop before you attend the Intermediate level workshop.

Workshop Objectives:

- Be a self-sufficient adviser by knowing your resources
- Develop interpretations of F-I regulations and guidance
- Interpret and develop institutional policy
- Learn techniques to advise F-I students on situations where clear guidance is not available

Conference Workshops

J Regulations - Beginners

Monday, October 25, 1:00 pm to 5:00 pm and Tuesday, October 26, 8:00 to noon

Audience: International student advisers working with an existing J-I program with less than 18 months experience in the field

This workshop is designed for beginners with less than 18 months experience in the field. Through various activities, participants will learn about the parties involved in exchange visitor programs, making decisions about J-I issues, use of SEVIS, J-I categories, regulations governing program sponsors, pre-arrival processes, health insurance, orientation for exchange visitors, the two-year home residence requirement, bar to participation as a J-I research scholar or professor and ongoing processes for exchange visitors. This workshop does not cover requirements specific to trainee, high school or graduate medical education categories, nor does it cover the procedures to obtain an exchange visitor program designation.

Workshop Objectives

- Summarize the purpose of exchange visitor programs, and describe its principal characteristics
- Acquire basic knowledge of your responsibilities and how to carry them out
- Learn strategies for approaching issues, problems, and situations
- Learn how to navigate SEVIS
- Gain confidence in being a J-I adviser
- Identify resources to help with J-I programs

J Regulations - Advanced

Monday, October 25, 1:00 pm to 5:00 pm and Tuesday, October 26, 8:00 to noon

Audience: Participants should have an intermediate knowledge and understanding of immigration and J visa regulations

This eight hour workshop will provide Responsible and Alternate Responsible Officers (RO/AROs) with a conceptual foundation, practical knowledge and skills for advising on J visa regulations. Topics include:

- The roles and responsibilities of the RO/ARO
- Ethical considerations
- The use of resources in problem-solving
- Decision making

This workshop specifically addresses advanced topics that lie in the grey zone for which there are no clear answers. It requires the participant to have an intermediate knowledge and understanding of immigration and J visa procedures. This workshop will not include basic procedural training, the trainee category or foreign medical graduates.

Workshop Objectives

- Develop conceptual foundation, practical knowledge, and skills for advising on J visa regulations
- Develop critical analytical skills for resolving J student and scholar visa dilemmas
- Exercise creative thinking powers for managing J visa programs
- Establish solid professional networks in the J visa community

Conference Workshops

Basics of Filing Academic H-1B Petitions

Monday, October 25, 1:00 pm to 5:00 pm and Tuesday, October 26, 8:00 to noon

Audience: International student and scholar advisers new to the H-1B program

In this workshop, you will learn the basics of the H-1B process. The workshop lays out the basic foundations of the H-1B program and takes you through the step-by-step process for filing an academic H-1B petition. By the end of the workshop you will have assembled a full H-1B petition. You will learn how to assess whether a position and the alien worker qualifies for the program, about prevailing and actual wage, preparing the Labor Conditions Application, building inspection files, the I-129 and dependents.

Workshop Objectives

Participants will:

- Identify the key government regulations and processes associated with academic H-1B nonimmigrant status and petition
- Acquire the skills and tools needed to file an academic H-1B petition
- Practice and complete an academic H-1B petition
- Be better prepared to advise their institutions and international employees on H-1B obligations and responsibilities
- Receive sample forms and resources to help manage the academic H-1B petition completion process

Welcome to New Orleans

The City that Care Forgot.

Jazz streams out into the moonlight, French doors open to the night breezes, sweet olive scents the air. Nearby there is laughter, a cork popping, and café brûlot aflame. Here, in this little corner of the American South, where European traditions blend with African and Caribbean influences, the history is as colorful as the local architecture. From this fertile ground came a completely new kind of music – jazz. The exotic, spicy cuisine is the stuff of legend. Carnival krewes, brass bands, Mardi Gras Indians, jazz funerals, St. Joseph's Day altars, All Saints Day – our traditions are uniquely rooted to this culture and place. We are a cultural gumbo and we celebrate our differences. In fact, we celebrate almost anything in the Big Easy. We have a saying: *Laissez les bons temps rouler* – let the good times roll. It's a reminder of our French heritage – a way of life that began three centuries ago.

History: Vintage 1718.

The party didn't start right away. Like good wine, it took a while to mature after the initial fermentation. When Sieur de LaSalle explored the Mississippi in 1682, he claimed all lands drained by the river for France and named the territory for the reigning royal, King Louis XIV.

The Louisiana Territory extended from the Mississippi to the Rockies, from the Gulf of Mexico to Canada. Over the years French, Spanish, English, Independent, Confederate, and Union flags would all fly over Louisiana. In 1803 Napoleon Bonaparte sold the Louisiana territory to the United States of America, effectively doubling its size. At a cost of fifteen million dollars, it was considered one of the greatest real estate bargains in history.

After the sale, Americans arrived *en masse*. Unwelcome in the Creole enclave of the French Quarter, they settled across Canal Street in what is known today as the Central Business District. The two factions frequently clashed, and subsequently formed separate municipalities with the Canal Street median serving as neutral territory. Since then, every city median has been called “the neutral ground.” During the 18th and 19th centuries, New Orleans dominated the Caribbean as the most active port city and trade destination for island crops like sugar cane, rum, tobacco and fruit. By the mid-1800s, the city in the bend of the river became the fourth largest in the U.S. and one of the richest, dazzling visitors with chic Parisian couture, fabulous restaurants and sophisticated culture.

After the Deluge, Renewal.

The recent history of New Orleans has proven to be a time of tremendous challenge. New Orleanians have braved many hurricanes over the years, but Hurricane Katrina, on August 29, 2005, proved to be the most devastating “natural” disaster in the history of the city and the country. After the levees encircling the city failed, 80% of New Orleans was left underwater. Thousands of homes, businesses, and schools were destroyed. As the magnitude of the destruction became apparent, each resident of the city had to make a hard decision – whether to pull up roots or rebuild a life in the city we love. Five years later, with the population at 78% and still growing, it is clear that most people have made a commitment to the city.

Today the rebuilding continues in earnest as citizens have been forced to rethink, revive and renew one of the world's most unique and beloved cities. Volunteers have poured in from all over the nation and world to be part of this effort. **Come see for yourself why New Orleans has captured the hearts and imaginations of so many for so long.**
