This conference featured seven preconference workshops, seventy-five conference sessions and a poster fair. Thanks to the efforts of the KC reps, the workshop coordinators and the poster chair, this conference was a professional development opportunity, par excellence.

Throughout the conference, participants had time to network and meet new colleagues. Most of the sessions included presenters from both Regions III and VII so the presenters, and the participants as well, shared perspectives from across an extensive part of the country—eleven states, Puerto Rico and the U.S. Virgin Islands to be exact.

The conference also offered attendees the chance to experience Puerto Rico on many levels. It got under way with Puerto Rico 101: An Introduction to the Island. Intensive English Programs Report—LaTesha Charbonnet Gonzales

This year's Bi-Regional NAFSA Conference in beautiful San Juan, Puerto Rico did not disappoint! From the delicious piña coladas and beautiful beaches to the savory food and warm and inviting Puerto Rican people, it was truly a pleasure to visit the island of Puerto Rico.

At the same time, the conference itself provided many invaluable sessions for those working in the field of Intensive English programs (IEP). Presentations, such as "Improving Intercultural Communication for International and Study Abroad Students" and "A Qualitative Study: Transitioning from ESL to a University-Results and Recommendations," both provided relevant information within the field of intercultural communication and matriculating students from IEPs to university degree programs. The poster fair was also a great addition to the conference with informative poster presentations entitled "Teacher Education: Language, Literature, Culture and Study Abroad Projects," "Are Your **English Requirements Setting** Your Students Up to Fail?," and "Orientation Before the Flight: Web 2.0 for the Newly Arriving English Learner."

One of the highlights of the conference was the session

entitled "Challenges, Benefits and Suggestions of hosting SACM Sponsored F-1 Students." Over the past few years, many IEPs have been inundated with Saudi Arabian students sponsored by the Saudi Arabian Cultural Mission (SACM), "a specialized agency created by the Saudi government to administer programs and policies to meet the educational and cultural needs of Saudis studying in the United States" (from http:// www.sacm.org/). This new population of students has provided some challenges for IEPs, including how to deal with the financial and academic aspects of hosting these sponsored students. Participants were able to ask questions regarding their students and share suggestions as to how to deal with such problems as tardiness, absenteeism, not completing homework, low levels of English, and Saudi-dominated classrooms.

In addition, the session entitled "U.S. IEP Accreditation and the December 2010 Law:
Consequences, Means, and Gentle Suggestions" was most definitely well timed. IEPs are by now familiar with the requirement from SEVP that all IEPs must be accredited. The Commission on English Language Program Accreditation (CEA) and the Accrediting Council for Continued Education and Training (ACCET) are two national accrediting

agencies recognized by the Department of Education. Unlike stand-alone IEPs, university-run programs do not have to be accredited through an outside agency such as CEA or ACCET. Instead, these programs have to provide letters from the university/ regional accreditor that confirms the IEP is a part of the university regional accreditation. However, the presenter did pose that even university-run programs may have to get outside accreditation from either CEA or ACCET in the future, both of which can be very timeconsuming and expensive.

Other highlights of the conference included the all conference dinner and closing celebration at the beautiful Antiguo Casino de Puerto Rico, the raffle prizes throughout the conference, the cultural performance by Ballet Folklorico Guamanique de Puerto Rico at the plenary luncheon, and meeting and planning with fellow Region III and VII NAFSANs.

Overall, the 2012 Bi-Regional NAFSA conference was a great conference in a wonderful locale.

experiences inspire more fervent advocacy than study abroad. These arguments seem increasingly compelling today as a growing list of economic, environmental, and technological challenges underscore our need for a more globally savvy and culturally interconnected populace. But beneath the appealing evangelism lies a perplexing reality: Despite annual press releases touting another "record" number of students abroad, the actual proportion of college students overseas has remained virtually unchanged. And as higher -education enrollments have grown more diverse, the demographic profile of those studying abroad continues to be mostly white and female. Furthermore, while many people have vociferously argued that studying abroad is the ideal way to gain crucial cross-cultural skills, a close look at the supporting research makes it difficult to be sure whether the findings amount to legitimate proof or preconceptions in search of corroborating evidence....read the full



U.S. Department of State (DOS)

New Visa Processing System at Mission India

In September, the U.S.
Department of State started implementing a new visa processing system throughout India. Some of the changes:

Visa application fees can be paid via Electronic Fund Transfer (EFT) or mobile phone, or in cash at more than 1,800 Axis bank branches.

Visa appointments can be requested online or by phone.

Companies and travel agents can purchase fee receipts and schedule appointments in multiples to facilitate group travel.

Visa applicants can ask questions via telephone, email, or online chat in multiple languages.

Iran Visa Sanctions Expanded

As part of ongoing government interactions with Iran regarding nuclear weapons, on August 10 President Obama signed into law the Iran Sanctions, Accountability, and Human Rights Act of 2012 [Pub. L.112-158]. The law expanded sanctions to include prohibition of issuing student visas (DOS) for and prohibiting entry into the U.S. (DHS)by Iranians wanting to study energy, nuclear science, or nuclear engineering. A number of questions remain regarding the implementation and impact of this law.

U.S. Customs and Border Protection (CBP)

DHS adds Taiwan to the Visa Waiver Program

As of November 1, 2012, eligible Taiwanese wanting to enter the U.S. as short-term tourists or business travelers may do so without first obtaining a B-1/B-2 visa. This is the result of Taiwan being added to the Visa Waiver Program (VWP). The new access applies only to the B-1/B-2 category. Students still require an F, J, or M visa to study in the U.S.

Programs for Expedited Entry into U.S.

Global Entry is a Customs and Border Protection (CBP) program that allows pre-approved, low-risk travelers to bypass long wait times at immigration inspection upon arrival in the U.S. The program works in conjunction with similar international programs (NEXUS, Privium, SeS, Sentri) to extend eligibility from U.S. citizens and Permanent Residents to include citizens of Canada, South Korea, Mexico and the Netherlands. In some cases the benefit also allows for expedited airport security screening. For more information, please see http:// www.globalentry.gov/.

CBP Discontinues Stamping of I-20 and DS-2019 Documents

U.S. Customs & Border Protection (CBP) issued a formal announcement that as of August 10, 2012 admission stamps will no longer be provided on Forms I-20/ DS-2019 for prospective and returning international students and scholars traveling with F, M, and J visas. This makes CBP processes consistent with the recent U.S. Citizenship and Immigration Service (USCIS) change to stop stamping Forms I-20/DS-2019 for change of status and reinstatement approvals. As a result, some international students and scholars have experienced difficulties with Social Security and driver's license offices. See the end of this article for supporting resources.

Transition to Paperless I-94 Continues

In August, U.S. Customs and Border Protection (CBP) announced the process of entering I-94 numbers into the Student Exchange and Visitor Information System (SEVIS) would be significantly delayed as part of the transition to a paperless I-94 process. Eventually, the I-94 card will be replaced with a passport stamp and handwritten annotation indicating the traveler's immigration status and date of expiration. Many employers use the I-94 as a way to verify nonimmigrant work eligibility on Form I-9 and E-Verify. Additionally, numerous state and federal agencies are dependent on I-94 data, so this change can delay benefit issuance. See the end of this article for supporting resources.

In a November stakeholder meeting a DHS official indicated that more changes will be implemented as soon as the U.S. Office of Management and Budget (OMB) approves current proposals. OMB has until mid-February to complete their review.

Student and Exchange Visitor Program (SEVP)

SEVIS I - Release 6.11

Expected November 30 but subject to change, the Student and Exchange Visitor Information

System (SEVIS) will be updated to 6.11. The release will update, correct and expand functions for F and J records affecting several areas, such as event history, recertification, PDSO assignments and OPT STEM extensions. See details at: http://www.ice.gov/sevis/schools/batch.htm.

SEVIS II

Development continues on the massive SEVIS II project. Current information indicates implementation in 2014/2015. Batch specifications are to be released 9-12 months prior to allow institutions time to prepare for the data transition. Regulatory changes will also be required. I-17 Updates

On November 2, 2012 the Student and Exchange Visitor Program (SEVP) announced a transition to accepting only electronic documentation for I-17 updates. The announcement included specific procedural and contact information for adding **Designated School Officials** (DSOs). For now SEVP will accept documentation through mail and email. The notice did not indicate when the mail option would end. All current DSOs received this information: see Broadcast Message 1211-02.

U.S. Citizenship and Immigration Services (USCIS)

Update: Deferred Action for Childhood Arrivals Update

As of November 15, USCIS reports receiving over 300,000 applications (3-5,000 per day) for the Deferred Action for Childhood Arrivals benefit. The majority of those applicants are now at the biometrics phase but 50,000 requests have already been approved. Many approved students are now receiving Employment Authorization Documents (EADs) allowing legal employment. For information about the benefit or for more statistics, see: www.uscis.gov.

USCIS Publishes Improved Form I-140, Immigrant Petition for Alien Worker

A new Form I-140, Immigrant Petition for Alien Worker, is now available from the U.S. Citizenship and Immigration Service (USCIS) Website. The format has been changed to improve intake processing and added Adobe fillable format features to make it easier for individuals to complete the form. Editions dated Jan. 06, 2010, and later will be accepted until Dec. 30, 2012. After this date, USCIS will only accept the Oct. 1, 2012 edition.

USCIS Changes Policy Regarding Original Documents

As part of the transition to paperless systems, USCIS Service Centers will no longer return original documents, such as I-20s and I-94 cards. Student and scholars filing for a change of status to F-1 or reinstatement, for example, should submit copies of the pertinent I-20s and I-94s and expect to only receive a receipt and decision letter for those applications.

USCIS ELIS Update

U.S. Citizenship and Immigration Services (USCIS) continues to develop the new Electronic Immigration System (ELIS) launched earlier this year. Use of the system is currently limited to visitors in selected visa categories whose requests involve using the Form I- 539, Application to Extend/Change Nonimmigrant Status. Government Relief Programs Extended for Haiti

On October 1, USCIS announced that Temporary Protected Status (TPS) and Special Student Relief (SSR) programs for Haiti would be extended. These programs were initiated in response to the widespread destruction caused by

earthquakes in 2010. These programs provide temporary status and work authorizations, and, for eligible F-1 students, suspend certain enrollment requirements. For more information, see www.uscis.gov.

Immigration and Customs Enforcement (ICE)

MAVNI Program Officially Reopened

As of September 27, 2012 the MAVNI program is officially reopened and expected to remain open until May 15, 2014. The Military Accessions Vital to the National Interest recruiting program (MAVNI) allows certain noncitizens in the U.S. to enlist in the Army to provide critical skills. Military personnel are often eligible for special considerations in applying for U.S. citizenship. Internal Revenue Service (IRS)

Nonresident Aliens Applying for **ITINs Face New Application Procedures**

In June, the Internal Revenue Service (IRS) implemented temporary changes to its procedures for issuing Individual

Taxpayer Identification Numbers (ITINs). The IRS policy changed from requiring copies of identity and foreign status to submitting original documents or copies certified by the issuing agency. In October, the IRS added two alternatives for noncitizens concerned about submitting original documents, a temporary ITIN process and a procedure allowing Designated School Officials (DSOs) to certify copies instead of the issuing agency. State of Texas - Medical Board

Texas Requiring All Medical Trainees to Practice in Underserved Areas

As of September 1, 2012, the Texas State Medical Board requires all foreign nationals who are not lawful permanent residents to practice in a medicallyunderserved area (MUA) or health professional shortage area (HPSA) for three years in order to be licensed in Texas. This rule, similar to one implemented in the state of New York, will primarily affect H-1B physicians completing a residency or fellowship outside of Texas who subsequently seek work in

Texas and physicians completing their residency /fellowship training on temporary H-1B visas in Texas who do not have a permanent license and who may wish to accept a practice opportunity in the state. The legislation will not affect physicians practicing in a graduate medical education program, even if it is located outside a MUA/HSPA, or those who obtained their medical licenses prior to September 1st.
