Report on Region III Conference

I want to begin by thanking everyone for their numerous contributions, both large and small, that helped to make the Region III Conference in New Orleans a great

success! I want to add a special thanks to the local arrangements team headed by Dr. Janice Thomas, who made it all appear seamless. A total of 388 people had the opportunity to participate in 6 pre-conference workshops, Academy Mentor and Participant training sessions, 2 pre-conference sessions on "How to do that in SEVIS", 49 concurrent sessions, one "slightly" off-Broadway presentation of "SEVIS hits Broadway", and an all conference event at the Generations Hall featuring Sunpie Barnes. I am happy to report that this event saw a record number of NAFSAns dancing way past quitting time. What a great event! Of the 388 registrants, I am pleased to report that this was the first Region III conference for 71 participants. This conference also marked the launching of the NAFSA Academy. Region III was pleased to have 13 participant programs and 13 mentors. By all accounts, this promises to be an exciting program that will bring new voices to NAFSA and new opportunities to serve our members.

Thanks to the generosity of Region III members, this year saw a record amount raised by the Region III Silent Auction and the raffle of a stunning pearl necklace donated by Whisnant Galleries of New Orleans and a large print donated by the local artist Robert Guthrie. The monies will go toward travel grants for future Region III conferences. With budget cuts and the unfortunate downward trend in international student enrollment, these monies will go far to ease the burden of travel and conference attendance. The most remarkable thing about this year's conference was the number, variety, and cross-sectional appeal of our concurrent sessions. We offered an unusually high number of sessions, with a record number of each appealing to more than one interest section. Even more remarkable was the range of presenters from lawyers to adjudications officers to students—all sharing their expertise and experiences to enrich fellow NAFSAns. In fact, the three sessions nominated for Best of Region and for possible presentation at Baltimore in 2004 demonstrated this diversity in both material and presenters. Nominated sessions were: "When Cultures Meet and the Bubble Bursts"—presenters Olesuen Ekunwe, Arnald Fosah, Eudaline Hell, Vanya Kasakova, and Maryam Rashid; "Moral Turpitude: The Consequences of Criminal Activity and Misrepresentation for Non Immigrants"—presenters David Ware and Debbie Danna; and "The Redesign of an Intensive English Program: A Case Study"—presenters Dr. Alan D. Lytle and Suzanne Lee. Best of luck in the selection process. I look forward to the opportunity to see one of these wonderful sessions at the annual conference.

I'm already looking forward with anticipation to Corpus Christi in 2004 and Colorado Springs in 2005! I hope to see each of you there.

Dan comes to this position with an attitude that has earned him the respect and love of Region III. Dan is a people person and an energetic colleague committed to our region. Dan's commitment to students is best seen in the numerous people to people programs he has implemented at Louisiana Tech. Louisiana State Report -- Alea Morelock Cot, Louisiana State Representative





In the session "Can You Hear Me Now?: Enlightening Policymakers on International Education" at the Region III conference in New Orleans in November 2003, participants were encouraged to reserve one hour a month on their calendar to dedicate to "advocacy issues". Your advocacy hour could include:

- Downloading and reading "In America's Interest: Welcoming International Students" (http://www.nafsa.org/ content/PublicPolicy/stf/inamericasinterest.htm) or "Toward an International Education Policy for the United States: International Education in an Age of Globalism and Terrorism (May 2003) (http://www.nafsa.org/ content/PublicPolicy/USIntlEdPolicy/NIEP2003updateFINALwebversion.htm).
- Sending an automatic email via the NAFSA website http://econstituent.votenet.com/ (yee3zm55vgxmy4agg2xzk12o)/index.aspx/nafsa/home.aspx> to your Senator or Representative. (Note: Following the links, this takes only about five minutes).
- Call, or write a local, state, or national government leader. Tell them what you have done during International Education Week, or about concerns you have dealing with international education.
- Meeting with your government relations person on campus to discuss international education issues and its importance.
- Reviewing all of the many materials and briefs NAFSA has on their website concerning policy issues (www.nafsa.org - "Public Policy" all links).

International education has taken a triple "hit" in the past two years: 1) the attacks on 9/11 have shed doubt on many issues of bringing international students to the USA, resulting in draconian changes in immigration laws affecting university foreign nationals, 2) concern for the safety of US students studying abroad, and 3) political and diplomatic unrest, causing tremendous challenges and competition for support and attention for international education by lawmakers. We are working in a field that has changed, and continues to do so on a daily basis. Personally, everyday I wonder if one of our foreign visitors is going to be adversely affected by a new law, security check, or something else that we have not been able to anticipate.

We must add advocacy to our job descriptions in order to reserve a small amount of time to educate ourselves and give a balanced perspective to university administrators, colleagues, friends and relatives, and to those who represent us in all levels of government. It is not unpatriotic to give a complete picture of what is happening as a result of the many new laws. I truly believe that in the effort to make national security a priority, negatively affecting colleges' and universities' foreign nationals was an unintended result.

Before September 11, 2003, I was one who never thought of issues concerning advocacy. When people called or asked me to send an email, I never paid attention, since it did not seem to be as urgent as the student who was in front of me with a problem. I realize now that problems far worse can occur, due to lack of educating those who can affect laws. Laws, that can negatively affect some aspect in our field, can pass through Congress in the matter of 1-2 days. Therefore, we need to be ready to respond, and do it quickly. We cannot afford not to add advocacy as a part of our jobs now.

One letter is considered 1,000 voices. One phone call is equivalent to 100 voices. Members of Congress rated letter writing from constituents as the #1 effective advocacy communication tool. Office visits were ranked #2, and telephone calls ranked #6. In response to a recent call in Texas for advocacy on the SEVIS fee law, there were 312,000 "voices" on Capitol Hill, as 58 NAFSAns responded with a total of 312 letters! (Continued on page 11)

In late October, a positive-toned letter explaining the "heads-up" and importance of U.S. International Education Week, and what NAFSAns from Texas did in IEW 2002, was sent to every Senator and Representative in Washington and Austin (both national and state congressional bodies). Many have written letters back acknowledging the importance of international education.

Mark your calendars for March 16-17, 2004 for Congressional Education Day, where NAFSAns will have a unique opportunity to meet "on the Hill" with their Washington representatives to discuss key issues facing international education. While you are looking at your 2004 calendar, earmark one hour a month for advocacy issues.

Immigration Update

The year has flown by, and keeping up with the rapid changes has been a challenge to say the least. It is imperative to continue to keep updated with the NAFSA Practice Advisories at www.nafsa.org/sevp. There is a new compilation of previous conference calls through this same site. It is wonderfully organized by topic. We would like to point out a few items of importance:

Texas Service Center News:

<u>I-765 Forms</u>: Some of the previous I-765 forms have become outdated, and TSC will not accept them, so be sure to download the most recent form for OPT and hardship applications. A reminder – if filing electronically, all the same support evidence must be submitted by regular mail noting the electronic receipt number on the application.

COS from OPT and during grace periods: There have been some denials for Change of Status applications from F-1 OPT and during F-1 grace periods. TSC has indicated that the student should prove that he/she has been working during the OPT period, and they have also indicated that the grace period is for transfers and preparing to leave. Although we are addressing these issues with the NAFSA liaison at the TSC and with Laura Taylor, it is advisable to be sure the student indicates on the I-539 form any employment he/she held during the practical training period.

<u>COS</u> applications to F-1: Be sure to monitor the program start dates on I-20's submitted for COS to F-1. If the start date passes by more than 20 days, defer it to a later date or the record could go invalid. Pay careful attention to the school's tuition, cost of living and incidentals. Also, remember to pay special attention to the funding evidence and review for clear statements of financial commitment with supporting bank statements.

Visa Issues and Automatic Revalidation/Deferred Inspections:

Third Country Nationals who are applying for visas in Mexico and Canada need to be aware that the consular officials are frequently taking the I-94's of students if the visa application is denied or security check procedures are begun. This makes it clear that the student is no longer eligible for automatic revalidation. Consequently, many students are approaching the port of entry to re-enter and many have been given deferred inspections. This does allow the student to come back into the U.S., but they are <u>not</u> considered to have "legally entered" the U.S. until the inspection is complete at the district office or local airport. This inspection has resulted in anything from a new I-94 with D/S, a charge to waive the visa requirement (\$195 for form I-193), voluntary departure, or even expedited removal proceedings (which carries a 5 year bar). Advisors will want to be sure that students are aware of the risks of applying for visas in contiguous countries if their current visas are expired.

SEVIS News:

<u>SEVIS' 30 day registration notification</u>: DHS has notified DSO's that they must perform the initial registration function within **30 days of the program start date** recorded in the SEVIS system and indicated on the student's I-20. For more updated information on recordkeeping and reporting, see NAFSA's SEVIS Resource 2003-a.

This resource also provides information on the recent DHS memo reminding schools that had been approved in SEVIS under the preliminary enrollment regulation [67 Fed. Reg. 44344 (July 1, 2002)] that the deadline for those schools to complete the SEVIS enrollment process, including payment of the required fee and having a site visit, is May 14, 2004.

NSEERS Registrants:

On December 2, 2003, the Department of Homeland Security (DHS) published a rule that amends several requirements associated with the Special Registration program. Under the new rule, individuals subject to Special Registration are still subject to departure controls that require them to use only designated ports of departure when departing the U.S., but they are no longer subject to the requirement to report to DHS offices in between entry and departure (the so-called 30-day and annual re-registrations). For further information see NAFSA's Practice Advisory 2003-F.

It is still imperative that registered students process out correctly when leaving the U.S. Students have reported that airport officials have given them erroneous information about the process or have told them that it is not necessary to do before departure. Unfortunately, if returning students have not followed the correct process, they could be turned away at the port of entry and required to apply for a new visa in their home country before they can return again.
