Report on Region III Conference

Imagine you are standing before a fifth generation of colleagues, 50 years from your first professional meeting as an association, and imagine what it would be like to look over that group and see the variety of backgrounds and witness their responses to the vision your generation was lead by. Dr. Joe Neal did not

have to imagine, he had the rare experience of giving a 50 year encore performance as he opened the Region III 50th Anniversary Conference held in Corpus Christi, Texas. From Dr. Neal's opening remarks, to the final wrap up, Region III experienced the depth and breadth of our profession's rich variety and warm friendship. Harriet Fulbright, the unofficial ambassador of International Exchange, delivered an inspiring message that set the tone for the days to come. We had several unique sessions this year that provided attendees with cutting edge, practical knowledge. Arkansas International Student Leadership Conference

In May 2004, Sue Marlay, Director of International Student and Scholar Services at Arkansas State University, and her Thai graduate assistant, Dilok Phanchantraurai, were awarded a \$2,000 COOP Mini-Grant from NAFSA for the Arkansas International Student Leadership Conference. Members of the conference committee, which included Katherine Vlassek, Henderson State University; Wayne Garner, Southern Arkansas University; Suzanne Lee, University of Arkansas at Little Rock; Michael Freeman and Cornell McClellan, University of Arkansas at Fayetteville; Lisa Shoemake, University of Central Arkansas; Nicky Boyd, Harding University; and Sue and Dilok, met at Harding University in Searcy, AR on July 20. During this meeting, committee members planned the conference program and allocated responsibilities for different aspects of the conference.

On September 17 and 18, 2004, fifty-five international students from thirteen colleges and universities throughout Arkansas attended the weekend leadership retreat at Harding University. These students, who represented thirty countries including the U.S., participated in informational sessions and group activities designed to highlight American values and leadership techniques. The sessions and plenaries included such topics as strategic leadership, leadership styles, time and stress management and American values and ethics. Both the facilitators and the program format assisted students in networking and developing skills they could apply to their leadership roles on campus.

It is the view of the committee members that the conference was wildly successful. The written and the verbal feedback indicate that the participants thoroughly enjoyed the conference and greatly benefited from their experience. All of the students who attended said that they would be interested in participating in a similar conference in the future. The committee has tentatively planned the next leadership conference for fall 2006.

Advocacy Corner: Advocacy Efforts in Region III

DVOCACY

Are advocacy efforts for international education making any difference at all? Absolutely YES! In fact this month, Congress approved a bill that increased funding for international education and exchange programs. I am convinced that it was the result of NAFSAns responding the Advocacy Alert requests and the easy on-line letter-faxing capability. Thank you to all of you who responded!

Advocacy Committee Update: As you may recall, in early 2004 the Region III team approved a proposal for the establishment of a new Region III Advocacy committee. Although there were no funds that could be allocated, that did not stop Region III in moving forward in breaking new ground in terms of advocacy. Under the creative mind and dedication of Michele Stelljes, and the hard work of John Singleton, funds have been raised for advocacy. John organized the first NAFSA Fun Run fundraiser. It was an unforgettable event to walk along Corpus Christi's seawall, see the beautiful ocean, and enjoy the company of fellow NAFSAns. This event creates a blueprint for other NAFSA events like it, and I truly want to acknowledge and thank John and Michele for making funds for advocacy possible for Region III!!

The first Advocacy Update meeting was held on Sunday, October 31st. Attendance included NAFSA members from all four states, all sections, past chairs, national leadership, leaders of partnering international associations, and NAFSA Central staff. We discussed the following:

- 1) Background of the Region IIII Advocacy Committee and what has been accomplished to date.
- 2) All money raised for advocacy will be equally divided between the four states in Region III. Since the advocacy needs for each state are unique, there will not be a requirement to use the money for subsidizing a trip to Congressional Education Day, as was in the original proposal. NOTE: \$3650 were raised for advocacy at this conference, resulting in \$912.50 for each state to use as they work to tackle their most urgent advocacy needs. There will be an accountability system in place for requests for funding advocacy projects.
- 3) Create a focus and strategic plan so that a system is in place to deal with specific issues. A.) Some issues could be decided through a resolution from Region III. B.) Most issues will be dealt with through national NAFSA leaders, who are have a system in place to handle the needs.
- 4) Advocacy is a never-ending process. We cannot raise awareness of the realities of international education one time and believe that it will just stay in the forefront of policymakers. Clearly, they are constantly balancing many priorities, and international education usually is not the most urgent issue.

If you are interested in being on the Advocacy Committee please let me know. We will begin communicating with all members by the first of the year, so that you can begin to enhance international education in your state.

On a different note, I wish to commend the 60+ universities and colleges in Texas who presented copies of the state House Resolution 143 (which encourages international education exchange in Texas) to their presidents or key officials at their schools. At Rice University, for example, the presidents of the international student clubs, as well as study abroad leaders, officially presented the original copy of HR 143 to our new president. This allowed all parties the unique opportunity to discuss the importance of international education, which served as a significant tool in raising its awareness on campus with key decision-makers.

Finally, I wish to thank all of you for allowing Region III to do groundbreaking work in advocacy. We will do all we can to pave the road so that others might benefit from our efforts, but most importantly, international bridges can continue to be built through sending US students abroad and bringing international students and scholars to Arkansas, Louisiana, Oklahoma and Texas!

Inaugural Dia de Los Muertos Dash at the Region III Conference in Corpus Christi

The 50th Anniversary of Region III kicked off with a run/walk along the beautiful Corpus Christi Bay sea wall. Over 90 NAFSANs and another 110 members of the Corpus Christi community participated in the event, with NAFSA proceeds going exclusively for advocacy efforts among the 4 states within Region III.

The event, co-sponsored by Roger Soler Sports of San Antonio, was the idea of Region Chair Michele Stelljes, who thought it might be a creative way to begin the conference in healthy fashion. This year's conference had a number of wonderful regulatory sessions such as those on undocumented aliens, 212(e) and advisory opinions, change of status, P/DSO issues, regulatory and consular updates. We appreciate all of you who presented and encourage those of you with interest to consider now what you might be able to contribute to next year's conference. Several of the presentations can be found on the NAFSA Region III website at http://www.nafsa3.org/. Another great first this year was the recording of the regulatory sessions on a single CD, giving some of you opportunity to attend other sessions of interests, and allowing you to take the regulatory sessions home with you.

The NAFSA Region III Team and the 50th Anniversary Committee did a fantastic job in helping us to celebrate the region's anniversary, and more than anything, this year's conference gave Jim and I the opportunity to reflect on why we do what we do. Most of us are in this field because we truly believe in international education and get pure joy from being a part of the process of bringing together international and US peoples for cultural and educational exchange. Although it seems that each year our responsibilities under the law increase and the time we have available to be involved with internationals on a personal level decreases, we believe that to truly help our students and scholars, we must take the utmost of care to meet those responsibilities and to stay up-to-date with the latest immigration information. Not to commit to these efforts can result in serious and sometimes catastrophic hardships for our students/scholars and can even jeopardize our programs. Even when we do everything right, the end result can still be extremely frustrating with lengthy data fixes, visa delays, and other problems which seem to arise in spite of our best efforts. Despite the difficulties, Jim and I continue to relish the opportunities we have to assist student/scholars achieve their dreams. When that happens, everyone wins and the goals of international education exchange are fully realized. As CIPP-RRs, we have the added pleasure of helping you help your students/scholars in meeting their goals. With that, we provide here some information that we hope will aid you in keeping up with the ever changing federal regulations.

USCIS District Office News:

InfoPass. For those in the San Antonio district, USCIS has now moved to the use of the InfoPass system. Student/ scholars need to be sure to make an appointment utilizing this system before visiting. To find more information on InfoPass go to http://infopass.uscis.gov/.

Updated Contact Information. We also have updated contact information on many of the district offices, so please contact Laura (cipp@tamu.edu) for the latest version if you didn't pick up the updated handout USCIS District Information for your district office at Corpus Christi. District Handouts include the following districts: Dallas, El Paso, Memphis, New Orleans, Oklahoma City, and San Antonio.

USCIS Texas Service Center News:

Updated forms. A new form I-102 was published by USCIS on 7/7/2004. Older versions of the form are no longer accepted. To keep up-to-date on the latest form changes see http://uscis.gov/graphics/newforms.htm.

COS and OPT approvals not showing in SEVIS as "Approved". We have received a number of reports that OPT and changes of status that are approved by the Service Centers are not reflecting the approval in SEVIS. We would suggest you monitor these closely and request data fixes when necessary.

Removal of the Standardized Request for Evidence Processing Timeframe. On November 30, 2004, USCIS published a proposed rule (http://a257.g.akamaitech.net/7/257/2422/06jun20041800/edocket.access.gpo.gov/2004/04-26371.htm) eliminating the required 12 week response time and allowing USCIS to set a time limitation based upon the complexity of the evidence being requested. The rule would also remove most provisions of the regulations that require issuance of a Request for Evidence (RFE) or Notice of Intent to Deny (NOID), thus allowing adjudicators to immediately deny a clearly ineligible application. Comments to this proposed rule must be submitted by January 31, 2005.

Adjustment of the Appeal and Motion Fees to Recover Full Costs. Another proposed rule (http://a257.g.akamaitech.net/7/257/2422/06jun20041800/edocket.access.gpo.gov/2004/04-26370.htm) was published the same day, November 30, 2004, raising the fee for appeals and motions to reopen to \$385.00. Previously the fees were \$110 for each option. Comments on this rule are due before December 30, 2004.

Address Change for Certain Immigration Filings. USCIS published a notice recently that individuals filing certain applications (I-485, I-765, I-131) with USCIS should mail their forms directly to the Chicago Lockbox instead of submitting them to their District Office. Please note that this does NOT apply to those filing Form I-765 to apply for an Employment Authorization Document (EAD) based on F-1 or J-1 visa status, such as Optional Practical Training [category (c) (3) (i)], J-2 work authorization [category (c) (5)], or employment authorization based on Economic Hardship [category (c) (3) (iii)]. Texas Service Center-NAFSA Liaison Meeting Solicitation for Questions. In early 2005 NAFSA hopes to meet with the Texas Service Center for its quarterly liaison meeting. Consular News:

Visa Delays/Denials. On November 22, 2004, NAFSA launched a new online visa delay/denial web-based questionnaire to enable members to report visa delays/denials caused by non-Mantis cases. Visa delays caused by security advisory opinion requests should still be in a separate web-based system. Reporting both types of cases is important to enable NAFSA to monitor the types and numbers of visa delays/denials. Visa Processing Times. The Department of State's web site has added a feature to allow you to check the estimated waiting time for nonimmigrant visa appointments and processing wait times at a particular embassy or consulate (http://www.travel.state.gov/visa/tempvisitors_wait.php).

USICE SEVIS News:

SEVIS Fee. On November 1, 2004, SEVP made available to students and exchange visitors the option to pay the I-901 SEVIS fee locally using the Western Union Quick Pay™ service. This option is available in any country where Western Union offers its Quick Pay service. Detailed payment instructions, including instructions on how to complete the Quick Pay form, are posted on ICE's SEVIS web site at http://www.ice.gov/graphics/sevis/i901/wu_instr.htm.

SEVIS Release 4.14. SEVIS Release 4.14 is due to be implemented on January 7, 2005. Highlights include the addition of the SEVIS F/M recertification fields/functions, ability for P/DSOs to correct educational levels on Active records, printing of the subject/field remarks on the DS-2019s, section 212(e) information, effective date of J transfer, a new alert to notify of initial J records 15 days beyond the program begin date, and much more.

SEVIS Terminations for Failure to enroll. On November 1, 2004, SEVIS began automatically terminating Active SEVIS records 90 days after the Next Session Start Date for those who had not been registered. Although, notices reported that this would NOT affect students on OPT, we have been recently getting reports from several institutions that certain OPT records have been automatically terminated. Those records affected include those where the program end date was in the future, but where the student had not been registered within 90 days from the date noted in Next Session Start Date field.

For example, a student may have graduated in May 2004 and began a period of 12 months OPT from May 15, 2004, through May 14, 2005. The student's last registration event would have reflected a Current Session End Date of 5/15/2004 and a Next Session Start Date of 8/30/2004. If the student's program end date in SEVIS was listed as December 18, 2004, and had not been shortened to reflect the May 2004 graduation, the student would have been terminated in SEVIS on November 29, 2004.

This is occurring because SEVIS is looking for certain criteria in utilizing this automatic termination function. If the program end date is in the future, SEVIS will begin looking for a registration event even if an OPT event is pending or approved. If the record has not been registered, the SEVIS record will be terminated 90 days after the Next Session Start Date. If the program end date is in the past, with OPT pending or approved, SEVIS will not be looking for a registration event, and the event will left unaffected.

Because of this, we recommend that all P/DSOs who have not made a practice of shortening programs to check the records for those students on OPT. If you do encounter records that have been terminated in error please report this to the SEVIS Help Desk and request a data fix. If you have a large number of records that will need correction, the SEVIS Help Desk has been providing P/DSOs with a spreadsheet which will allow them to report all these errors with one ticket number. We know that SEVIS is aware of this issue, but we are not sure at

this time how they plan to address it. Unless noted otherwise by SEVIS, we recommend that you begin

to utilize the shorten program function to shorten the program end dates for those students who have graduated. Students on OPT, who have not graduated, should continue to be registered in SEVIS until completion.

Employment Based News:

There has been a flurry of activity in the H-1B arena. First the cap was reached on the first day of the fiscal year. Then, Congress included some significant changes, some really welcome and some really bad news, to the H-1B program in the Fiscal 2005 Omnibus Appropriations bill, including an exemption foreign nationals from the cap if they had Master's or higher degrees from a U.S. institution. Here's the details:

H1-B Cap reached — proposed regulation. On October 2, 2004, USCIS Service Centers started rejecting H-1B petitions filed for cap-subject employment beginning on or after that date. On November 23, 2004, USCIS published an official notice in the Federal Register that the FY2005 H-1B cap had been reached on October 1, 2004. The notice also temporarily suspended e-filing of H-1B petitions and included information on procedures for handling H-1B's filed before October 1, 2005. Omnibus Bill The good, the bad and the really stinko. Congress included some very interesting changes to the H-1B program in the FY 2005 Omnibus Appropriations Legislation. As with all legislation, the implementing regulations will be critical to the interpretation and application of the new provisions. This is a laundry list of those provisions:

The Good - ** Aliens who have earned a Master's or higher degree from a U.S. institution of higher education are exempt from the cap, with a numerical limitation of 20,000 per year. ** The DOL is required to provide four wage levels in governmental surveys to determine prevailing wages. Where an existing survey has only 2 levels, 2 intermediate levels may be created by (actual language of the bill) "dividing by 3, the difference between the 2 levels offered, adding the quotient thus obtained to the first level and subtracting that quotient from the second level." ** DOL must consider an employer to be in compliance with regulations if the employer has made a good faith effort to comply with regulations, not withstanding a technical or procedural failure to meet such requirements. The devil will be in the regulatory details on this part. ** If an employer can establish that the manner in which the prevailing wage was calculated was consistent with recognized industry standards and practices to pay the prevailing wage and is subsequently found to have violated prevailing wage requirements, it will not be assessed fines or penalties for the violation.

The Bad - ** Reinstitutes the training fee as a permanent fixture and raises it from \$1,000 to \$1,500. The good news is that universities and colleges are still exempt the fee. ** The bill provides expanded authority for DOL to initiate investigations but more clearly defines reasonable cause that an employer is not in compliance with regulations and requires personal certification by the Secretary of Labor that reasonable cause exists.

The really stinko - ** Employers will now be required to pay 100% of the prevailing wage. Until now, only 95% was required. ** The bill added a new \$500 fraud fee which applies to everyone, including universities

and colleges. The fee applies to employers filing an initial petition for an H-1B and applies only to the principal alien, i.e. dependents applying for H-4 status are not subject to the fee.

Other Employment-based News:

Some confusion resulted from USCIS's announcement of the expansion of it's Direct Mail Program for I-485's. The requirement to submit I-485's to the Chicago lockbox facility does not apply to employment based applicants, only to family-based, diversity lottery and a few other unique categories. Employment based applications and related documents (I-485, I-131, I-765) still go to the Regional Service Center having jurisdiction over the place of employment. These changes will *not* affect I-765s filed by F and M students, J exchange visitors, or other nonimmigrants.

New ETA-9035. The DOL announced the requirement of filing a new version of the Labor Certification Application for H-1B petitions. For those of us who file our ETA-9035's electronically on the DOL website, the new version is already incorporated therein. This new procedure is a result of changes relating to H-1B's for Singapore and Chile and the necessity to distinguish between standard H-1B's and those for Singapore and chile.

Change, Change, and More Change: How Do We Keep Up?

It seems almost impossible to keep up with the large number of regulatory changes that occur on a daily basis, and by the time this newsletter is published, several other news pieces may have been published. There are a multitude of resources available, but few as comprehensive and reliable as those provided by NAFSA. We encourage you to make use of the wonderful NAFSA resources by going to www.nafsa.org/sevisresources and www.nafsa.org/practice. Check it daily!
