CIPP-RR Update

Miriam Schoeman and Ravi Shankar, CIPP-RRs, NAFSA Region V. Dear Region V Members,

As you know, much is happening legislatively and in law enforcement in the wake of September 11, 2001. This article identifies current issues and points to resources for further information. It also identifies issues unrelated to September 11 that will affect international student and scholar advising in the near future.

1. ADDITIONAL NAMECHECK CLEARANCE FOR CERTAIN NONIMMIGRANT: On November 13, 2001, the State Department imposed

tougher screening procedures on visa applications for certain Foreign Nationals resulting in delays in visa application processing. This will affect mainly men from specific Middle Eastern countries who are between the ages of 16 and 45. Details including whom is affected by this measure and the following two measures can be found in the NAFSA Practice Advisory entitled "New Travel and Visa Measures Affecting Certain Nonimmigrants" at www.nafsa.org.

- 2. **TEMPORARY SUSPENSION OF TCN PROCESSING IN MEXICO AND CANADA:** On November 19, 2001 the State Department temporarily suspended third country national (TCN) entry visa application processing in US Embassies and Consulates in Mexico and Canada. Most appointments have been cancelled. Individuals should check with the specific consulate or embassy with which they have an appointment to find out whether their appointment has been cancelled before finalizing travel plans. The Department of State website provides updated information at http://usembassy.state.gov.
- 3. **NEW NONIMMIGRANT VISA APPLICATION:** As of November 30, 2001, the standard Nonimmigrant Visa Application form has been redesigned and renamed Form DS-156. This replaces Form OF-156. The new form can be downloaded from the Department of State website at http://travel.state.gov/ds0156.pdf.
- 4. **RELEASE OF STUDENT RECORDS:** The NAFSA practice advisory on release of student records to government officials has been updated to include the new FERPA exception created by the USA PATRIOT Act. Section 507 of that Act added a new "investigation and prosecution of terrorism" exception to FERPA. The new exception allows the Attorney General or an Assistant Attorney General-level Federal officer or employee designated by the Attorney General, to apply to "a court of competent jurisdiction" for an ex parte court order requiring an educational agency or institution to permit the designated Federal official to collect and use "education records" that are "relevant to an authorized investigation or prosecution" of an act of terrorism or an offense associated with terrorism. - 5. **NONIMMIGRANT RIGHTS BROCHURE:** The American Civil Liberties Union has written a brochure entitled "Know Your Rights" designed to help nonimmigrants understand what to do in the event of questioning by government officials. It may be useful to download this document and make it available to your clients. This brochure may be found on the ACLU website and is available in PDF format at http://www.aclu.org/library/know your rights.pdf.
- 6. **FEE INCREASES:** The Immigration and Naturalization Service has proposed a rule to increase fees for certain applications and petitions. The proposed rule was published in the Federal Register on August 8, 2001. The new fees will take effect after a final Notice is published (see below). Please see http://www.gpo.gov/su_docs/aces/aces140.html to access the Federal Register of August 8, 2001 to see proposed fee increases for each type of application or petition. Look for the final Notice in an upcoming Federal Register. **Newsflash:** The Immigration and Naturalization Service (INS) has published a final rule in the Federal Register that increases processing fees (66 Fed. Reg. 65811). The new rule takes effect on February 19, 2002. The new final rule would raise I-129 fees to \$130, I-140 fees to \$135, and I-485 fees to \$255. Any applications or petitions mailed,

- postmarked, or otherwise filed, on or after February 19, 2002 will require the new fee. According to INS, the "fees need to be adjusted to recover the full cost of the benefits provided."
- 7. **INS INTERNAL RESTRUCTURING**: On November 14, 2001 the INS announced that it has developed a restructuring plan "that fulfills President Bush's pledge to fundamentally reform the agency by creating a clear division between INS' two vital missions -- service and enforcement. The separation of these functions, while retaining a single agency head to ensure appropriate coordination, balance and policy leadership, will help improve the efficiency and effectiveness of the agency and, in turn, the nation's immigration system."

According to the INS, "the restructuring plan can be implemented administratively without requiring legislation. As a result, with the support of Congress, the reform can begin promptly and can be accomplished by the end of FY 2003."

Major Elements of the Plan

- 1) Maintains a Single Agency Leader
- 2) Separates INS Enforcement and Services
- 3) Creates Separate Services and Enforcement Field Structures
- 4) Increases Accountability
- 5) Addresses Customer Concerns
- 6) Protects Children
- 7) Enhances Enforcement
- 8) Focuses Customer Service
- 9) Preserves Vital Service and Enforcement Links Necessary to Screen Individuals and Enhance Security
- 10) Improves Data Systems and Interagency Information Sharing
- 11) Fosters Strategic Intergovernmental Relationships

Our ADSEC presence was plentiful and diverse. Many of the ADSEC sessions were filled to capacity. I had the pleasure of meeting many of you for the first time. If any of you "newcomers" made at least one helpful contact or garnered one new bit of information, then consider your attendance highly profitable!

We were extremely fortunate to learn about the Brazilian Educational System and the Brazilian Student from Julieta Jacob, OSEAS representative from Brazil. In addition, she also presented a Poster Session explaining "a day in the life" of an OSEAS office. Having an OSEAS presence at our regional conference is incredibly rewarding. Julieta's attendance was a perfect opportunity to experience the ADSEC-OSEAS Liaison Project first hand. Not only do ADSEC members learn about a foreign educational system and OSEAS members learn what information we need to do our job, we all learn how we can help each other to promote NAFSA's and our own institutions' goals.

Graduate Admission officers benefited from a session, which covered U.S. university eligibility for graduates of foreign medical programs of study. There were sessions on Professional Development for the ADSEC member, Indian professional association qualifications, and recruitment overseas. Newcomers were able to freely discuss their concerns and questions at an ADSEC roundtable session. In addition, the ADSEC and Community College groups met in a session to discuss official educational documentation issues. Finally, as always needed, a Governmental Q & A session supervised by our CIPP representatives and INS guests was overflowing with attendees.

Because of the tragedy of September 11th, your regional team organized an early morning session covering NAFSA-related issues. There were, and still are, many concerns regarding U.S. legislation, foreign student visa regulations, and individual campus issues. As we know, news changes from day to day. Therefore, your regional team recommends you check the NAFSA website daily for updates, press releases, and advocacy actions.

On behalf of your Region V team, I would again like to thank all of the presenters and chairs for their hard work preparing and presenting their sessions. I know many attendees were happy to see such a diverse range of sessions offered. It's that "NAFSA volunteerism" that is outstanding and rewarding for all.

Learning in the Light! SECUSSANS Bridge Research and Practice in Grand Rapids

Formal evaluations from The NAFSA Region V Conference in Grand Rapids were exceedingly positive. Feedback suggested that presenters were talented professionals who combined research and practice to deliver timely and relevant topics.

The informal collection of comments and feedback that buzzed across the floor of the conference hotel centered on:

- The Wake Of The September 11 Tragedy And The Impacts On Education Abroad Offices
- The Development Of A Strong Research & Practice Ethic That Contributes To Advocacy Efforts
- NAFSA'S Role In Professional Training
- Opportunities to Volunteer with SECUSSA Regional Activities

911 Impact: The Study Abroad 101 Workshop welcomed 16 professionals to an 8-hour training session on study abroad advising and administration. Many of the participants have been in the field fewer than 6 months or have been assigned the task of "starting-up" an education abroad office within their institution. The presenters commented that they have witnessed considerable growth in the field over the past several years, and have seen changing standards and competencies for entry-level professionals related to experience, education and technical skills. We were fortunate to have Maureen Powers (Dean of Students, IES) and Louisa Wales (Student Services Coordinator, IES) deliver a fast, furious and fruitful segment on health and safety at the 101 session. IES is a model institution for the development of policies and procedures

not only in safety but also in assessment (The IES Map for Study Abroad: Charting a Course for Quality). Bill Nolting, SECUSSA National Chair and many SECUSSA Colleagues have put together an awesome web site, *Promoting Health and Safety in Study Abroad*. The Region wishes to thank Joe Kinsella (co-chair), Tom Howard (co-chair), Gloria Barr, Brad Lauman, Maureen Powers and Louisa Wales for their hard work as volunteers who prepared and delivered this daylong workshop. THANKS!

Developing Strong Research and Practice Ethics: Many SECUSSANS and NAFSANS mentioned that they were happy to attend sessions that not only discussed good practices, but also based these practices on solid, timely research (primary or secondary). *Taming the Tiger of Data Collection* and *Study Abroad and the Faculty Perspective* were two very strong sessions that sharpened our assessment and evaluation skills (wipe the dust off of those stats books!) and provided excellent models for data collection and how to use research in practice.

Building a Study Abroad Office: Two Experiences, One Rotten Apple: Group Dynamics in Study Abroad and Study Abroad: Plans, Pains & Progress offered us experiences, somewhat "harrowing" at times, that demonstrated our capacity as professionals to reflect, strategize and improve while working in an environment of constant change.

Finally, Study Abroad in the Rainbow Nation received evaluation accolades of "THANK YOU SO MUCH!" "Excellent!" "Great Session!" This presentation complemented Consul General Kisten Rajoo's opening keynote, by offering first-hand experiences and insights to South Africa's transition to democracy, from a South African native and a returned Peace Corps volunteer/Education Abroad Administrator.

The Region wishes to thank all of the volunteer chairs and presenters who made the conference a success.

Professional Training: The Study Abroad 101 workshop was very successful. Participants, however, commented that the time is pressured and that there are areas that might be better covered in an extended workshop or in a conference session. Traditionally, the Region has offered 101, apart from the Professional Practice Workshops (PPW's) offered by NAFSA Central. The Region is in the process of considering which PPW's might be offered at future conferences. I am interested to hear your thoughts and feedback related to professional development needs so that I may communicate them to the Region and to the Central Office.

MAFSA will hold its annual conference at the **Holiday Inn in Mt. Pleasant March 20-22**. Sessions covering all sectional interest areas, pre-conference workshops on student and exchange visitor visa programs, government Q&A, and a special session focusing on post 9/11 issues are planned. Watch for a conference email and mailing in January. MAFSA has several types of grants available to those wishing to attend the conference. The first type, the *Newcomer Professional Development Grant*, is open to people who have been in the field of international education exchange for less than one year and who have never attended a MAFSA conference. This grant was established to encourage individuals to attend the conference and to assist them in getting professionally oriented. Individuals who meet the qualifications and who are interested in applying for the grant should submit a one-page proposal on why they believe they qualify and how

obtaining this grant will contribute to their professional growth. Two recipients of the Newcomer Professional Development Grant will be selected and awarded up to \$150.00 to cover direct conference costs (travel, hotel, registration fee, and meals). FBI interviews in Michigan

Due greatly to the large Arab-American and foreign student populations in Southeast Michigan, a number of students at Michigan colleges received letters from the FBI to participate in its voluntary interview program related to the government's antiterrorist efforts. School officials dealt with an array of concerns and questions and helped students to find legal assistance and other resources such as the American Civil Liberties' Union and the Arab American Anti-Discrimination Committee. The ACLU of Michigan prepared a brochure on student's rights related to interviews or detention which is on the ACLU web site in English, Arabic and Spanish at http://www.aclumich.org/issues/question.htm.

Kay Clifford at the U of M Ann Arbor indicated that around 80 U of M students and staff received letters. U of M faculty and lawyers offered and provided accompaniment to students at the interviews. One of the students interviewed indicated that the interview was an easy and relaxing event. The students greatly appreciated the support from the university community and area organizations. David Kent at the University of Detroit accompanied two students to interviews. David said the officials were very respectful in their questioning and that the students were pleased with the way the interviews went. Questioning focused on student, employment and contribution activities; whether they were targeted for harassment because of their background; did they know anyone who showed interest in the September 11 events or were encouraging "jihad" or U.S. government overthrow; and whether they owned firearms. David said the interviews took only 15-20 minutes. David had also provided information and emailed to students regarding sources of assistance. Congratulations to Kay, David and the many other Michigan university officials who helped these individuals through this experience.

Openings on the Team

If you are interested in becoming a member of the Region V Team, there are several openings upcoming.

COMSEC Representative

The COMSEC representative represents the interests of the Community Section, one of the five sections of NAFSA for our region. The COMSEC representative is expected to have knowledge and experience working with community volunteers. The COMSEC representative plans program sessions for the regional conference and other activities for the membership in the region. The representative also serves as a liaison between regional COMSEC members and the COMSEC national team, facilitating a two-way flow of information. This is initially a one year position, renewable annually for up to two additional years. Prior service on a state team may be helpful. Attending both the annual regional conference and spring planning meeting, and contributing to each newsletter are essential. NAFSA membership is required.

Treasurer

The Treasurer is responsible for: 1) managing the assets of the Region and maintaining appropriate financial records in accordance with the regional bylaws and national standing rules. 2) Ensuring that all accounts payable are closed in a timely manner after approval of the Regional chair. 3) Managing the Region's financial reserves in such a way as to maximize the interest generated. 4) Ensuring that the income/expenses ratio remains favorable. Otherwise, notify the Regional Team so the appropriate measures can be taken to ensure the Region's financial solvency. 5) Preparing an annual budget and presenting it to the Regional team for approval. 6) Preparing quarterly and annual financial reports to the Regional Team including a financial report of the regional conference. 7) Submitting an annual financial report to NAFSA by July 1, including a financial report of the regional conference, in compliance with the National Office requirements. 8) Ensuring that regional fundraising conforms to the NAFSA Guidelines for Fundraising. 9) Paying the regional expenses with the approval of the chair. Previous experience in managing sizable budgets is required. Attending both the annual regional conference and spring planning meeting is essential. NAFSA membership is required.

TECHSIG Liaison

The TECHSIG Regional Liaison will 1) identify relevant computer topics and coordinate the organization of computer-related sessions for the annual regional conference, 2) identify individuals at the regional level who can contribute to regional conference sessions and training efforts, 3) arrange for the distribution of TECHSIG and other computer-related information and training materials at the regional conference, 4) serve as a regional resource for those with questions about access to and/or use of Inter-L and other electronic forums of interest to international educators, 5) identify technical issues at the regional level to bring to the attention of the national TECHSIG Steering Committee, 6) advise the Regional Team on technical issues related to conference planning and other team efforts and initiatives, 7) assist with the creation of a regional web site, in coordination with the regional team, 8) help the Region to utilize available technology to a greater degree than at present. Requirements: The TECHSIG Regional Liaison must be available by e-mail, as it is via e-mail that communications will be relayed to and from the TECHSIG Steering Committee. This a three-year position. Prior service on a state Team may be helpful. Attending both the annual regional conference and spring planning meeting, and contributing to each newsletter are essential. NAFSA membership is required.
