Greetings! I hope all of you are beginning to enjoy and appreciate the much-awaited spring weather. I know that with all the global happenings, our jobs as international educators have recently been challenging: SEVIS, SARS, the war in Iraq. We continually do our best to meet the demands of the profession and our international community. Certainly, the recent developments have impacted the lives of our international students and scholars as well as travel and study abroad.

To deal with insurmountable pressures from all directions, the NAFSA region V team are thinking and planning ways to assist you all professionally and personally. The NAFSA Region V team has embarked on many innovative strategies in order to effectively meet the needs of NAFSAns in our region. Last March 1-3, 2003 we were involved in a strategic planning exercise and from there came out with ACTION TEAMS that will tackle exciting endeavors.

As regional chair, I gave the action teams a charge to pursue these innovative approaches effective March 13, 2003. I would like to share with you the details of the charge.

THE PURPOSE

- 1. The ACTION TEAMS will provide a structure for establishing a region-wide perspective regarding identified priority areas through the voices of the region team members and the NAFSA region V members.
- 2. The ACTION TEAMS will serve as a vehicle for conveying critical information germane to the region V issues.
- 3. The ACTION TEAM members will share information and perspective with one another and create meaningful collaboration to come up with collective recommendations for Region V team and membership consideration.
- 4. The ACTION TEAM members will work collectively to represent the best interest of the region and the team while keeping in mind their professional interests.
- 5. The ACTION TEAMS will provide important recommendation regarding priority areas of Region V.

THE PROCESS

At the end of eight weeks, the action teams will:

- 1. Develop a set of recommendations within a priority area (with costs, feasibility, achievability as a major consideration)
- 2. Give the rationale for each recommendation based on the criteria chosen by the action team.
- 3. Present the recommendations to the regional team in Utah.
- 4. Present a general overview in the regional updates meeting and ask for input from membership.

By late June, the action teams will:

- 5. Present the final reports to the Region V team
- 6. The reports will be posted on our website and emailed to members.

By November 2003, the chair stream will:

7. Present the accomplishments of the action teams during the business meeting in the regional conference in Milwaukee.

MESSAGE FROM CHAIR - ELECT

I would like to take this opportunity to update you on a couple of changes to our annual conference scheduled for Nov. 9,10 and 11 at the Pfister Hotel in Milwaukee. The general format will be quite similar to that of past years but we are going to try to do something a little different with the exhibition hall.

Based upon feedback from exhibitors and from material gleaned from a workshop at the Washington Leadership Meeting we are planning to have the exhibition hall open on Sunday evening and the Monday of the conference

but not the half-day on Tuesday. Our rationale for this decision is that traffic slowed considerably on the half day at the close of the conference and that our exhibitors spent most of their time talking with each other.

Exhibitors have also indicated that closing the hall on the final day of the conference will save them one night's hotel expenses and allow them to visit other regional conferences that may be held at the same time.

In order to insure that traffic flows into the hall on Monday we will be holding our continental breakfast and breaks in the hall as usual, plus one additional event at the end of the day. Last year we held silent raffles during the breaks in order to allow for conversations and business discussions in the exhibit hall. This met with a mixed response from conference attendees. Some were happy that they didn't have to talk over the PA system but others were not happy that their wares and sponsorship were not noted in any meaningful way to the conference attendees. So, we are going to hold a mega-raffle at the end of the day on Monday in the exhibition hall. All items will be raffled off at this time and we are planning to solicit a few major items as well.

In between our arduous meetings, discussions, and debates, we also enjoyed wonderful lunches. And as a resident Milwaukeean, I showed our team members just how close in proximity we would be to some of our local attractions, which will be enjoyable during your conference free time. Am I starting to tempt you to attend our region's November conference?

I hope that the ADSEC offering at the conference will meet your needs. We will be offering a beginning credential evaluation pre-conference workshop, as well as country, recruitment, and immigration sessions. Now is the time I ask you: can you help? If you have a suggestion for a session, would like to chair a session, or would graciously wish to share your expertise and present one, please contact me. As I write this, I know that the session and workshop proposal forms are not yet ready on our region's website. The proposals will be due in June; so now is the time to start talking amongst yourselves, start thinking of what you'd like to see, what you'd like to do, or how you'd be willing to help your fellow ADSEC members. Per our National NAFSA office, ADSEC activities include a variety of tasks, two of which I believe are of utmost importance for us to do our job properly, responsibly, logically, and ethically.

1. Training: The Pan-NAFSA Committee on Education and Training, with great input from our national ADSEC teams, have created, organized, and presented a variety of Professional Practice and Foundations of International Education Workshops and established a fantastic ADSEC Trainer Corps Team.

In addition, NAFSA will begin implementing a multi-year training program with 2003-04 designated as the pilot year. This program will assist institutions of higher education, particularly community colleges and small colleges, in the establishment, expansion, or strengthening of international education departments on their campuses. 2. Publications: Several changes have occurred over the last few years resulting in fewer published resources for NAFSA's ADSEC membership. While there are not-for-profit organizations such as Educational Credential Evaluators, Inc. (ECE) and International Education Research Foundation (IERF), to just name two, who do publish country studies or offer grants for country study research, the Pan-NAFSA Committee on Communications and Information [COMINFO] has the responsibility of recommending policies and priorities for NAFSA's publications program, among other duties. When I meet in Salt Lake City with the National ADSEC team, I hope to highlight my concerns regarding the lack of newer resources and what can be done to increase ADSEC membership participation in an activity so vital for us to do our job well. For example, the well-regarded 1999 NAFSA publication, edited by Shelley Feagles, *A Guide to Educational Systems Around the World*, is out-of-print, and currently, I've heard of no news of a reprint or a revision.

I do not want to sound so pessimistic regarding resources; therefore, I must bring to your attention, if you haven't heard, that the Publications Department at the American Association of Collegiate Registrars and Admissions Officers (AACRAO) is liquidating their existing inventory of International Publications in a special sale. This might be your last chance to acquire some much-needed books. See their catalog online at http://www.aacrao.org/publications/catalog/international.htm. Take advantage of this sale, now!

Also, AACRAO has established **IPAC**: International Publications Advisory Committee. The chair of this committee, Kenneth Warren, founder of Educational Perspectives, has informed me that the goals or intentions of IPAC are "to solicit and recruit authors for publications pertinent to international education to be published by AACRAO. It is the job of IPAC to review current resources in international education and determine which publications need to be updated, or to recommend manuscripts that should be published." These are not limited to full-country studies.

Current members of IPAC are Jane Shepard, Marjorie Smith, Becky Hanson, Christopher Foley, and Gloria Nathanson. Publications that are in the works are: *Taiwan*, co-authored by Muriel Zhou and Julie Hu; *Brazil*, authored by Lou Nunez; Christopher Foley's "white paper" on *The Educational System of Kyrgyzstan*, and Kate Trayte's publication on *France*.

Finally, at the end of this year's fall conference, my three-year assignment as Region V's ADSEC representative will end. Working with Region V's team has been and continues to be an on-going pleasure and has benefited greatly my own professional development. I hope to continue to be involved in our Region's activities in the future.

SECUSSA UPDATE

Secondly, our dedicated state SECUSSA representatives have been in the process of assembling a region wide study abroad fair calendar for program representatives, student travel organizations and other Education Abroad resource providers who face the daunting challenge of attending as many of the increasing number of study abroad fairs during the Fall, 2003 term(s) as humanly possible. This undertaking is obviously near and dear to my heart (last Fall I personally attended 25 study abroad fairs and I only worked in parts of five Midwestern states). BCIS Notes

Service Center:

The Bureau of Citizenship and Immigration Services plans to close the Information Officer telephone lines at the service centers and shift them to the national 800 number beginning June 1, 2003. The national Immigration Information Officer will make an inquiry to the service center and then contact the applicant, petitioner or representative.

Electronic Applications:

On April 25, 2003, BCIS announced that beginning May 27, 2003, that it plans to offer e-filing for form I-90 (Resident Alien Card Replacement) and I-765 (Employment Authorization Card). BCIS will also collect a photograph, signature and fingerprint electronically. Once an application as been filed, the applicant will need to call the Nation Customer Service line at (800) 375-5283 at an Application Support Center (ASC) for the biometrics. DHS/DOS Clarification:

Kathy Bellows forwarded this message to the CIPP-RR list on the issue of students using the "old visa" for entry to the US to begin studies at a new school:

After speaking with DHS and DOS yesterday afternoon again about this specific issue, NAFSA was informed by both Stella Jarina of DHS and Tim Smith of DOS that a student will NOT need to apply for a new visa if the visa was already used once before to enter the U.S. regardless of whether the new I-20 is from a different school. For example, a student obtains a visa using School A's I-20 stating "initial attendance." The student is given a five-year visa. After two years, the student withdraws for a period of

time (time period is insignificant). During the 4th year, the student decides to start school again and is admitted by School B. School B issues a new I-20 for "initial attendance." The student may use the original visa and School B's I-20 to enter the country because the visa was used once and hasn't expired, even though it shows School A on it. (Same as the pre-SEVIS process.) Sorry for causing this confusion.

OPT after Reinstatement:

BCIS has confirmed to NAFSA, that a student is still eligible for OPT after reinstatement, if they had been in legal status for 9 months before falling out of status. If you have had any cases denied based on this, please contact Ravi Shankar.

DOS NOTES

According to AILA, the U.S. Consulate in Ciudad Juarez plans to resume processing of certain non-immigrant visa from TCNs. Visa renewals will be accepted from TCNs whose initial visa was issued in the home country. The consulate will also accept from TCNs who obtained a change of status from BCIS, except if the initial non-immigrant category was B1 or B2. They will process Bs if they the I-94 had the "prospective student" annotation.

SEVIS

Deirdre Hollingshed of NAFSA originally forwarded this information on the issue of SEVIS and consular post.

A new process has been developed to provide for the handling of files not found in SEVIS at consular posts overseas*. This solution will replace the ad hoc solution, sending emails to Larry Bell and Tim Smith, that has been in place since February when the posts began using their version of SEVIS for electronic verification of documents for visa issuance. This new process could reduce the amount of time it takes for a SEVIS record to show up in SEVIS at the consular post by 24 hours. You will receive a confirmation email acknowledging receipt. Please do not include any additional information in the email, or send more than one email for each record fix request, to the SEVIS help desk account. NAFSA has been assured by EDS that their staff will take the appropriate action and send the record to DOS by close of business on the third business day, at the latest, following transmission of the confirmation email.

Until this process was established, records were checked and corrected by Tim Smith, deputy chief post liaison division at DOS, who has worked tirelessly on behalf of schools and programs in fixing records lost in this data transfer. The Consular Affairs Working Group of NAFSA has worked hard serving as the conduit for this information in support of schools and programs who have had difficulties with this process. Mr. Smith and CAWG will continue to monitor this and other visa difficulties, but record fixes should now be done through the help desk.

* All NAFSAns should take note of the fact that SEVIS is not "live" at consular posts overseas. For security reasons, consular officers access SEVIS through the Department of State's intranet known as CCD not live off of the internet. Electronic information is passed from SEVIS by DHS to DOS for uploading into their intranet. Occasionally this has caused files to be delayed in loading into CCD and this in turn has caused some student or dependent's records to not be seen at the post when they do in fact appear in SEVIS. Records, which are brought to the attention of the help desk, will be checked and resent if necessary so that they appear in the DOS version of SEVIS.

As a result of the tremendous frustration expressed by colleagues about malfunctions in SEVIS, Jason Jonely cited specific examples of problems experienced in a letter that was later mailed to all Wisconsin Members of Congress on behalf of our state membership.
