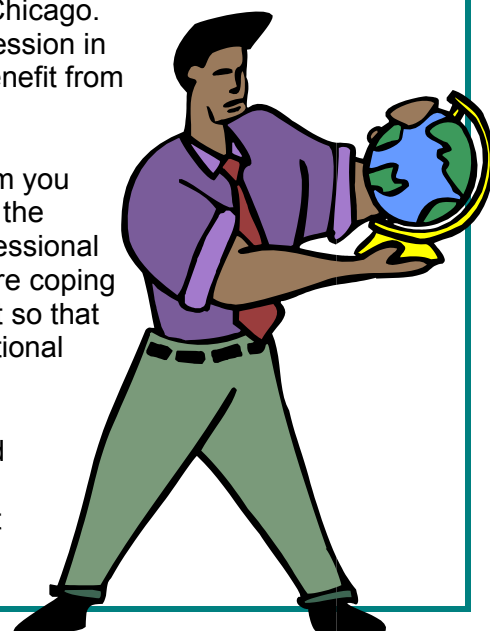
It has been my honor and great pleasure to serve as the Region V Conference Chair for the past year, especially so because of the wonderful group of people serving on the Regional Team and Local Arrangement Committee (LAC) headed by Kate Zheng, Patricia Walters, Beth Hoffman-Lopez and Susan Weber. My thanks and gratitude goes out to all the team members, the presenters, exhibitors and LAC volunteers for making this past conference such a success.

The 2004 Region V Conference offered 48 sessions along with seven pre and post conference workshops focusing on government policies and good practice in all professional fields. A total of 398 people registered for the conference. Among them, 167 were from Michigan, 122 from Illinois, 58 from Wisconsin and 53 from other countries and states. Thanks to Nancy Katz's hard work, we had a record of 32 exhibitors and vendors participating in our conference. I am pleased to report that this conference also marked the launch of the NAFSA Academy in Region V. NAFSA Academy provides an excellent opportunity to expand the number of qualified international educators in our Region. This assists many institutions in developing international education offices, expands the pool of individuals available to participate in NAFSA regional activities and leadership positions and offers leadership opportunities for senior NAFSAs through participating as Mentors.

The "Regional Highlight" session this year went to "Alone in the World; Solo Recruitment Travel", chaired and presented by Saskia Hoffman from the School of the Art Institute of Chicago. Congratulations to Saskia! If you missed this session in Ann Arbor, you will have a second chance to benefit from it at the national conference in Seattle.

This year as Regional Chair, I hope to learn from you about your needs and your thoughts about how the NAFSA Region V Team can enhance your professional development. We also need to hear how you are coping with the current changes and fiscal environment so that we can do a better job of advocating for international education.

Let me encourage you to share your talents and knowledge with other NAFSAs in Regional V. NAFSA will not be a strong organization without strong support from people like you. Your



involvement in regional leadership, your participation in conference presentations and your volunteering in regional events are all critical to the success of our organization. Keep in mind that by better serving others we will also better serve ourselves.

ATESL: Administrators and Teachers of English as a Second Language

As everyone is well aware, the NAFSA structural changes as outlined in the Strategic Plan has required that ATESL also rethink its role within the NAFSA organization. The ATESL national leadership has been attempting to define ATESL's role within this new structure, and ATESL members can see the results at www.atesl.nafsa.org/strategicplan.asp. The Next Generation TOEFL is another change to impact the ATESL membership and international students at the university level. The new TOEFL will be in use as of September 2005 and will incorporate a speaking test. This new test is designed to help universities better assess academic readiness through the language skills a prospective student is able to demonstrate in integrated skills tasks. The changes can be viewed at www.ets.org/toefl/nextgen/description.html. At our Region V Conference in Ann Arbor in November 2004, this topic was a featured ATESL presentation. Region V held its first round of NAFSA Academy activities at the Regional Conference in Ann Arbor in November, and 12 participants and their mentors are off to a great start! The Academy offers a 20-month intensive, tailored program for participants to systematically learn the various elements of international education, set goals for their own learning and pursue the development of programs in their own institutions. The first step is a series of meetings at the Regional Conference, followed by an intensive three-day Spring Training in March, then additional activities and training at the Annual Conference. In year two, the cycle continues, and at their second Annual Conference, participants complete their training and graduate from the Academy.

When we met the participants in this Academy class in Ann Arbor for the first time, I was incredulous at the wide variety of experience, talent and skill represented by the group! Collectively, participants have lived in several dozen countries, have worked in a wide range of fields, and bring a wealth of experience and interests that is truly astounding. I look forward to working with all of them and learning from them as much as providing training. While we all expect to work quite hard toward our goals, I also expect that we will have a great time together.




Save the date and let us know if you would like to do a presentation or help out in any other way with the Illinois NAFSA State Conference. **Presenters, please send your proposal by February 10, 2005.** Give us an idea of what you would like to present and a little information about your experience. We are interested in having a variety of NAFSA sections represented under each theme.

This will be an issue-based conference with four sessions corresponding to each of four basic issues. Within each issue, we hope to address topics of interest to members of the various sections of NAFSA. Friday morning we hope to have a panel of legislators to talk about what is on the horizon for immigration legislation and then a choice of basic workshops related to study abroad advising, immigration advising, and/or admissions. The four basic conference issues are:

- 1) **Crisis Management - Expecting the Unexpected** (Possible sessions: Formulating a crisis management plan, Health care, Mental illness, Handling a crisis for study abroad students, Panel discussion of a specific concern for international students, Detention of students by ICE or others.) If you would like to do a presentation on one of these topics, contact Tracy Klickman, issue coordinator at klickman@cdnet.cod.edu.
- 2) **Immigration/Government Issues** (Possible sessions: Social security numbers, Driver's license issues, Current issues with USCIS, CBP presentation, Creative solutions, Obtaining a visa, Hot topics, Consular processing.) If you would like to do a presentation on one of these topics, contact Elizabeth Matthews, issue coordinator at e-matthews1@northwestern.edu.
- 3) **Promoting Tolerance in an Intolerant World** (Possible sessions: Cultural programming; re-entry programming for study abroad students; strategies for admission in attracting international students; promoting study abroad; developing exchanges) If you would like to do a presentation on one of these topics, contact Colleen Earley, issue coordinator at cearley@roosevelt.edu.
- 4) **The Hunt for Resources** (Possible sessions: Obtaining resources for recruiting/admissions work, Solo recruiting, Money saving alternatives to travel for recruiting, Sources of funding for international students, Funding for study abroad.) If you would like to do a presentation on one of these topics, contact Rubee Fuller, issue coordinator at R-Fuller@neu.edu.

Friday Workshops - tentatively following panel of legislators, two and a half hour time frame, include: Introduction to Immigration Regulations, Introduction to Study Abroad Advising, and Nuts and Bolts of Admissions Work. In addition to our opening reception, other interested events being planned include a mock immigration proceeding and tours of the Canadian Consulate and USCIS Detroit District office.

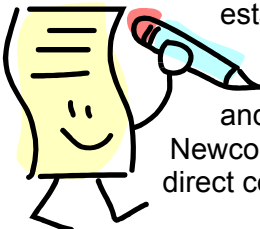

Please consider the MAIE grant opportunities available to conference attendees:

Newcomer Professional Development Grant: Open to people who have been in the field of international education exchange for less than one year and who have never attended a MAIE conference. This grant was established to encourage individuals to attend the conference and to assist them in getting professionally oriented. Individuals who meet the qualifications and who are interested in applying for the grant should submit a one page proposal on why they believe they qualify and how obtaining this grant will contribute to their professional growth. Two recipients of the Newcomer Professional Development Grant will be selected and awarded up to \$150.00 to cover direct conference costs (travel, hotel, registration fee, and meals).



Best of State: For anyone whose session is accepted at NAFSA Regional, MAIE will help defray the costs by providing conference related expenses (not to exceed \$250.00).

Student Grant: This grant is for students who are currently working or volunteering with an international office and are interested in a career in international education. MAIE will waive conference registration.
