This past year has been a great experience, working with wonderful people throughout Region V in preparation for the regional conference held last November 6-8 in Springfield, Illinois. The local arrangements team, headed by Rick Bystry and Ali Soltanshahi, did a fabulous job of taking care of a myriad of details to make the conference a success! Hats off also go to the Region V team, presenters, plenary speaker, exhibitors, and sponsors for their outstanding contributions to the conference.

The Springfield conference included 46 sessions and six pre- or post-conference workshops that provided valuable information on a wide variety of topics of interest to international educators. Conference registrants included 154 from Illinois, 117 from Michigan, 71 from Wisconsin, and 44 from outside the region. Twenty-two exhibitors filled the exhibit hall. For the second year, Region V participated in the NAFSA Academy, with additional meetings and workshops for Academy trainees and mentors. The Academy connects newer international education professionals with experienced mentors and provides the trainees with a wide breadth of training and skills enhancement across the spectrum of international education.

The Regional Highlight session for the Springfield conference was Renewing Your Spirit, chaired by Sara Thurston-Gonzalez from the University of Wisconsin-Madison, and presented by Sara and Liz Matthews of Northwestern University. They will be presenting this session at the national conference in Montreal.

This will be an exciting year for Region V NAFSA members as opportunities to become involved in the association grow. Members can join the new Knowledge Community Networks that best reflect their interest and job duties. The networks are a central place to identify resources and information and to communicate with others concerning issues in our field. IssueNet is another new service of NAFSA, enabling members to submit issues related to government regulations and policies for NAFSA

NAFSA Academy has successful first year and kicks off second year at Regional Conference in Springfield

The Region V NAFSA Academy trainees have made remarkable strides in their first year. After beginning their training program and being matched with a mentor at the 2004 Regional Conference in Ann Arbor, trainees and mentors worked diligently together to create a Learning Plan for the year based on individual trainee's learning goals.

In March 2005, the trainees attended an intensive three-day Spring Training in Chicago. This training provided a venue to showcase the projects they have accomplished in addition to attending Education Abroad Advising, International Student Advising, and Community Programming and Foreign Educational Credentials Analysis Core Education Programs (CEPs). At the Annual Conference in Seattle in May 2005, the trainees met with their mentors and attended a variety of activities.

The trainees began the second half of their 20-month training program at the Regional Conference in Springfield, IL in November 2005. They had the opportunity to meet with their mentors and create a second-year Learning Plan, assess their professional competencies, develop professional networks, and attend the J-1 and Beyond Advising PPWs. The trainees will attend another three-day Spring Training in March 2006 and will graduate at the Annual Conference in Montreal in May 2006.

The NAFSA Academy, supported by funding from the Bureau of Educational and Cultural Affairs of the U.S. Department of State, is an extraordinary program. Many language programs entered 2006 anticipating an influx of students from Saudi Arabia with scholarships which support English language study before their participation in an academic program. Despite problems in getting a visa, students have steadily arrived and increased the diversity in our English language classroom.

In other developments, the iBT (internet-based TOEFL) is now in use. Test registrations have been filling up fast for many test sites, and students should be encouraged to book a test date and site well in advance of requiring the result. TOEFL's web site: www.toefl.org does a nice job of describing the iBT and offers a practice test site. Students at the MSU-English Language Center have returned to tell us that the activities and exercises practiced in classes daily were the skills directly tested by the iBT.

Finally, having just returned from an English language testing trip to the People's Republic of China, I found the enthusiasm toward American universities in full force. The easing of visa issuance has excited the average applicant and the largest number of enthusiastic, prospective graduate students that we've ever accommodated arrived to take our test. These are all positive signs for a successful 2006 in international education in Region V!

SECUSSA/Study Abroad

A belated Happy New Year to you all! I hope that the Year of the Dog is treating you well.

As many of you may already know, the US Senate has unanimously passed a resolution to designate this year as the "Year of Study Abroad." The resolution encourages not only higher education institutions to expand and promote study abroad opportunities, but secondary schools, businesses, and government programs as well. Please thank your senators for passing this, especially for those of you in Illinois and Wisconsin since Senators Richard Durbin (D-IL) and Senator Russ Feingold (D-WI) were two of the sponsors of the resolution.

Were you or your students finding it difficult to obtain visas from the Spanish Consulate in Chicago this past fall? Apparently, you were not alone. In early November, the consulate had posted a message on its website indicating that the earliest time to schedule the required appointment to process a student visa would not be until late January. This news affected more than 2,000 students planning to study in Spain during the spring. Over 70 institutions reported their problems on NAFSA's IssueNet, and NAFSA was able to use this information to press for a solution from the Spanish Embassy. The Spanish government responded promptly by increasing its staffing in the Chicago consulate on November 21, and it appears that the issue has been resolved. As other problems or issues arise, be they visa issues or not, I encourage you to report them on IssueNet, which is located in the Regulatory Information section of NAFSA's website.

The Lincoln Commission on Study Abroad presented its final report to the public on November 14, 2005. The Commission's ambitious goal is to have one million students studying abroad annually by 2016.
