Rose Mary Valencia	HIIG so far	Rose Mary reviewed our accomplishments so far: HIIG is only 2 years old but we have many members and more activities than older MIGs; introduced new chairs and chair-elects; we have had 2 successful webinars: one with ECFMG & one regarding prevailing wage/iCert issues; we have an active list serv & website; there were 3 regional meetings/presentations in 2010; a workshop & a session in 2009 and a session in 2010. Rose Mary invited everyone to introduce themselves and discuss one or two issues they would like to see discussed in webinars etc.
Ron	Hot Topics not covered in	1)Eleanor Fitzpatrick raised the following issues: ECFMG is seeing more inquiries about sponsorship for CME
Klasko	the Session held 6/2; ideas for future webinars	programs which require a tuition and are short-term, the J-1 alien physician is inappropriate, she would like to hear from institutions on any suggestions she can take to DOS; also in the planning is a discussion with DOS regarding research integrated into residency programs;  2) several audience participants raised the issue they are facing with prevailing wage determination and veterinary medicine residents;  3) Special handling Labor Certifications (PERM) for faculty are coming under scrutiny, DOL is questioning whether they are eligible for the "special handling" provision of the PERM regulations. Prior to implementation of PERM, if the faculty taught even just one class they qualified.  4) a possible Webinar with the Association for Hospital Medical Education (AHME) re: best practices for using the J-1 vs. the H-1B; "volunteering"; observers; overview of various institutional policies and how to develop them
