

NAFSA Region VI Business Meeting  
Lexington Downtown Hotel, Lexington, KY  
8:00-9:00am, Tuesday, November 11, 2008

Sue Miller opened the meeting at 8:11am.

Sue Miller welcomed everyone to the meeting.

Secretary Report – Meri Linn Emerson

Minutes from the Regional Update Meeting in Washington, DC in May are located in the back of the room. They have been posted online on the NAFSA Region VI website. Membership has decreased since May, 2008. The region as a whole has 533 members (down from 630 in May -- 83%. Indiana has 192 current members (down from 249), Kentucky has 88 current members (down from 96), and Ohio has 243 current members (down from 285). Currently, we have 66 new members (down from 149 in May), 18 community college members (down from 39 in May), and 1148 non-members (up from 963). Indiana holds 36% of new members, Kentucky holds 16% of new members, and Ohio holds 46% of new members.

Sue Miller mentioned that if you join today, you will receive half-price membership. Stop by the NAFSA booth for more information.

Sue Miller asked for a motion to accept minutes. Tammy Orahod seconded the motion. Minutes approved unanimously. Minutes will be posted online.

Treasurer Report – Polly Harrington (given by Opal)

We have not yet reflected expenses or income from the conference. Registration and sponsor fees will be calculated. Question asked: do we have a goal for how much money to keep? Opal Leeman Bartzis mentioned that we want enough money that we could do a regional conference and state meetings in case something happens to our conference locations. We are doing fine. Sue Miller mentioned that this is our biggest expense and source of revenue and those numbers will be made available to everyone later. We have many grants to give, and state representatives can provide more information. We are trying to look for ways to put money back into the region.

Registrar Report – Kathy Ice-Wedding (given by Jennifer Marinello)

We had 320 people register for this conference. We have been having a lot of fun and learning a lot about Kentucky. Evaluations will be sent via e-mail, very soon after our team meeting on Wednesday. We won't have budget figures until May. We will try to use the same money we spent the previous year for special events.

Academy Update – Sara Allaei

There is a difference between Academy and Trainer Corps – NAFSA Academy is an opportunity for intensive professional development for a class of selected individuals, supported by the region, for 9 months. It is designed for people who are new to the field, to give them a broad view of the field. Sara Allaei will be the coach for next year's

academy. Please promote the academy to anyone you feel would be interested. Application deadline is December 1. Trainer Corps is for experienced NAFSAs who would like to be trainers for NAFSA. Jennifer Marinello mentioned that we need trainers for the Foreign Credentials workshop. Interested parties need to apply in the fall in order to participate the following year. Information will be posted on the regional website.

Sue Miller explained the flow of what the NAFSA team does and often the team meets.

#### KC-EA Report – Thelma Rohrer

Sue Miller mentioned that Thelma's position is open starting in 2009. Anyone who is interested should talk to Thelma and go to the website to look at the job description.

NAFSA national is revising recruitment publications. They have revised a mammoth list of websites and books on credentials evaluations and educational systems. NAFSA is creating a new "Parent's Guide to Education in the United States." The final draft form is in editing. "The Guide to Student Recruitment" is being updated with e-Recruitment strategies. "The Guide to US Educational Systems" is being updated as well. They will be online in early 2009. NAFSA is also producing a new Credentials 101 resource book to come out in 2009.

Marlin Howard discussed the new research grant that the team came up with. Anyone in NAFSA would be eligible to receive this research grant. The form should be done tomorrow and will be posted on the website. We are not sure how many grants will be awarded.

#### KC-Teaching, Learning, Scholarship Report – Krista McCallum Beatty (given by Sara Allaei)

Krista sends her best. KC-TLS is broadening to include mid-career professionals and people who are fairly well-advanced in their careers. She encouraged everyone to look at what is happening in the KC at the national conference.
