Membership - Jennifer Marinello

Membership has increased since last year, the region as a whole has 538 members Indiana has 183 current members (down from 192), Kentucky has 106 current members (up from 88), and Ohio has 249 current members (up from 243).

Currently, we have 73 new members (up from 66), Indiana holds 26% of new members, Kentucky holds 26% of new members, and Ohio holds 48% of new members.

We have 30 Community College members (up from 18), and 1015 non-members (down from 1148). IN 384 KY 151 OH 480.

<u>KC-Community College Report – Chad Broecker</u> The Community College KC lost it's representation at the National Level. Now we have completed guidelines. Each Community

College will have a meeting to go to at National in order to have our structure back at the National Level.

<u>KC – Education Abroad – Stephanie Leslie –</u> There is lots of Education Abroad information on the NAFSA website. Please use Issuenet to post complains about visa issues. Secussa-L is still active but we really should subscribe the KC networks via the NAFSA website. NAFSA encouraged students nationwide to submit videos about their study abroad experiences for the 2009 Student Diplomat Video Contest. Deadline was Nov 6. The video was to be 1-3 minutes long. Students could win \$300 cash. We created a list of H1 N1 Resources.

<u>KC – ISS – Melissa Ochal & Sandi Lemons -</u> F-1 regulations are being significantly revised. There are major changes coming to SEVIS, called SEVIS II. Phase one will be in February 2010. This affects members in the field of Admissions as well as those who work in International Offices. SEVIS are going paperless and students will get an Immigration Identification number (IIN) and there will be specific name conventions that we must use when entering data. If you are not up on this information, please consult the good resources listed on the NAFSA website and the USCIS website. This is huge and you must think about how it will impact your institution and your office. Both of us are rotating off the team.

<u>Regulatory Ombudspersons Report –Joanna Snyder</u> Sam is getting married so he cannot be with us today. J subpart proposed regulations are out. The deadline to comment on them is December 15. Institutions are encouraged to send a comment to the proposed regulations, the deadline to comment on them is November 23. SEVIS II is coming, sessions to be held tomorrow at the conference with more information.

<u>KC-RAP Report – Marlin Howard –</u> There could be three RAP representatives on the team. One for Recruitment, and one for Admissions and one for IEPs. There are so very few IEPS represented in NAFSA. IEPS have outside accreditation. I fear they will loose interest if we do not keep an IEP representative on the team and keep them visible. I compiled a list of IEPs in the region.
