SEVIS II

Wondering what's the latest on SEVIS II? DHS published an FAQ on the matter on January 9, which you can access here: http://studyinthestates.dhs.gov/assets/pdfs/FAQ_compiled_2013-01-09.pdf No specific date for deployment is included, however, the FAQ provides a comprehensive set (42 pages) of questions and answers that may be of interest, such as this one:

Q: If SEVIS II will not be implemented until 2014 or later, is training relevant at this point?

A: While training might not seem relevant at the moment, detailed information on how SEVIS II will differ from SEVIS is important. These differences have the potential for changing how schools administer their F and M programs and how they manage their business processes and interactions with students. Knowing what changes SEVIS II entails allows P/DSOs to examine their existing processes, identify what changes need to be made, and work with campus partners to effect those changes.

New DS-7002: A note has been added to the Advisor's Manual that at least gets us thinking in the right direction in regard to the workers' compensation questions. If you have any feedback on this, then please let us know.

* Worker's Compensation and Student Interns. The latest version of the Form DS-7002 T/IPP includes questions about the Worker's Compensation policy at the site of activity. For the student intern category, 22 CFR 62.23(i)(3)(iii)(D) has always required student internship program sponsors to "adequately screen all potential host organizations at which a student intern will be placed by obtaining the following information: ... (D) Verification of Workman's Compensation Insurance Policy." Although this worker's comp provision is not included in the part of the regulations that defines what has to be in the T/IPP, it is an obligation to get information about a host organization's worker's comp policy, so the Department of State likely saw the T/IPP as a convenient way to standardize how that information is collected, and for verifying that it has been collected by the sponsor. Since this section of the DS-7002 must be completed for the "site of activity," it must still be completed even when the site of activity is at the program sponsor itself, rather than a third-part "host organization." Sponsors should familiarize themselves with the worker's comp policies of the states where internships will take place. Worker's comp requirements themselves are generally a matter of state law, and some categories of "workers," unpaid interns, for example, might be exempt, depending on the state. The DS-7002 T/IPP only asks "yes or no" questions regarding worker's comp, though, and so there isn't a space to indicate anything about exemptions.

Exchange Visitor Program--Fees and Charges: As we discussed on our last conference call, the 1/30/2013 Federal Register included a notice of proposed fee increases with an April 1 deadline for comments.
