## ICE Overview

U.S. Immigration and Customs Enforcement (ICE) was formed in 2003 as part of the federal government's response to the 9/11 attacks, *ICE's primary mission is to protect national security, public safety and the integrity of the U.S. borders* through the use of laws governing immigration, border control, customs, and trade.

# ICEICE OverviewCTCEUICE Overview

- ICE is responsible for preventing terrorist and criminal activity by targeting the people, money, and materials that *may* support terrorist and criminal organizations. ICE is responsible for investigating a wide range of domestic and international activities arising from the illegal movement of people and goods into, within, and out of the United States.
- ICE investigations cover a broad range of areas, including national security threats, financial crimes and smuggling violations (including illegal arms exports), crimes, commercial fraud, human trafficking, narcotics importation, child pornography and exploitation, and immigration fraud.



## The CTCEU & SEVP Team

#### **CTCEU Mission**

Prevent terrorists and other criminals from exploiting the nation's immigration system, proactively scrutinize associates of known potential terrorist, identify terrorist criminal enterprises and expand the coordination within the various Intelligence Community and Law Enforcement Agencies.

The CTCEU proactively pursues it's mission by reviewing the immigration status of potential, known, and suspected terrorists, and by combating criminal exploitation of the SEVP.

# ICEU

#### SEVP

•Develops, recommends, and implements ICE policies related to foreign students and learning institutions.

•SEVP manages and utilizes the Student and Exchange Visitor Information System (SEVIS) to track and monitor SEVP approved schools, students, and exchange visitors throughout the duration of their approved participation within the U.S. education system.

**Outreach - Purpose** 

• Directed to academic and vocational institutions that are certified by ICE to enroll nonimmigrant students and exchange visitors.

• This initiative will focus on opening communication channels between DSOs and local ICE agents with the goal of ensuring a growing and robust foreign student population and program by addressing potential school fraud, identifying nonimmigrant student threats and radicalization.





#### **Outreach - Background**

- DHS has expressed an intention to expand programs related to the enforcement of nonimmigrant visa overstays and to shift the civil immigration enforcement responsibilities to ICE's Office of Enforcement and Removal Operations (ERO).
- This restructuring will allow HSI to better focus on addressing potential vulnerabilities in student and exchange visitor programs, national security issues, and foreign student visa fraud.

#### **Outreach - Scope**

- •Discuss recent fraudulent school investigations with DSOs and identify SEVP laws and regulations that touch upon current issues.
- •Inform school officials of current indicators and patterns of criminal activity which will enable them to better identify and report criminal behavior.
- •Yield information of suspected school fraud within the institution's foreign student body, or by other regional SEVP-certified schools.
- •Discuss requests for student information that are exempt from the Family Educational Rights and Privacy Act (FERPA) rules, emphasizing how this information will be requested.

#### **Outreach - Phases**

• <u>Phase 1</u>: Institutions that solely provide English as a Second Language (ESL) Training. Approximately 60% of all language school transfers are to other language schools and approximately 40% of <u>all</u> active foreign student transfer to an ESL course of study.

• <u>Phase 2</u>: Flight Training Institutions. Nine of the 9/11 hijackers and conspirators received, or attempted to receive, flight training in the United States.

• Phase 3: Exchange Visitor Programs (J Visa)



**Outreach - Presentation**
