# Education Abroad (EA) Update — Laura Moix

#### New Research on Study Abroad's Influence on Personal Growth

International educators have long sought research studies to support their direct observations: Students, when they return from study abroad, appear more mature than when they left. Is this due to the fact that the students are older, or is there something about the experience abroad that has accelerated their personal growth? While previous case studies suggest the experience itself influences this growth, a recent study by Zimmermann and Never warrants special attention by moving beyond a single university or a small sample size. Their finding: After study abroad, students indeed show more accelerated development in some of psychology 's standard "Big Five" personality traits - openness to experience, conscientiousness, extraversion, agreeableness, and neuroticism — and that is a refreshing insight into the "transformational experience" so often talked about in the field. #### I-17 Accreditations and Recognitions Conversion Project

There is currently a onetime conversation of all SEVPcertified schools' accreditation/ recognition information on fields 10 and 11 of the electronic Form I-17. The format of these fields was changed due to a SEVIS Release. All conversions must be complete by July 19, 2014 or the accreditations will be listed as "none." #### SEVIS I & II Update

As SEVIS II development has officially ended, SEVP is still developing new functionality to SEVIS. Be ready for changes including standardized information requirements such as name formats, address validation for consistency, and updates to displayed OPT information. #### **Optional Practical Training**

Please remember that under 8 C.F.R. § 214.2(f)(11)(i)(B)(2), Form I-765 and I-20 with an OPT recommendation must be submitted within 30 days after the DSO updates SEVIS with the recommendation. USCIS Service Centers will deny or issue Requests for Evidence (RFE) based on this 30 day deadline. If a student receives an RFE for this reason, it is best practice to cancel the OPT request in SEVIS and create a new request before mailing the new I-20 promptly.

USCIS also emphasized the necessity of including proof of all previous CPT in OPT Applications. CPT can be indicated through copies of all previous I-20s or if all previous I-20s cannot be located, a SEVIS screenshot of the student's history of CPT can provided by the DSO should be sufficient.

Please note that if students choose to e-file their I-765, biometrics will be required.

As of now, the Texas Service Center is not requiring copies of transcripts to be sent in with I-765 applications for postcompletion OPT. However, it was brought up by USCIS at the NAFSA Annual Conference that transcripts can be requested and are required by other service centers. If there is a clear adjudication error when filing an I-765 with USCIS, you can contact your Regulatory Ombudsman, Amanda Brinlee, through IssueNet to have the case addressed.

Many students are now requesting their OPT applications to be expedited. Students must be able to prove that they fit the expedition criteria as a result of their application not being approved quickly. A list of the criteria can be found on the USCIS website at <u>www.uscis.gov</u>. Students must first contact the National Customer Service Center at 1-800-375-5283.

#### **ELIS Updates**

The Electronic Immigration System (ELIS) has been active for over two years now. It has helped expedite applications by allowing students to upload new documents immediately and re-

spond to RFEs quickly. It is important to review all uploaded documents to ensure they are legible, and to ensure that all required documents are being submitted. USCIS is looking to move to a new platform (most likely a fillable PDF) for ELIS in 2015 to make the system more user friendly.

If you have issues with a case, please note that only the Vermont and California Service Centers are adjudicating I-539s. If you have an issue with a specific case, it is best to choose one service center to contact. If they are not adjudicating your specific case, that service center is still instructed to assist with questions and locating the correct service center.

#### **Travel Information**

As a reminder, it is important that students and scholars receive valid travel signatures on their I-20s and DS-2019s before attempting to re-enter the country. If a student or scholar attempts to re-enter the United States without the appropriate travel signature or documentation, it is still procedure that CBP admit the student for 30 days and issue an I515A. It will be up to the DSO or A/RO to assist the student with the I515A. For more information on form I515A, visit http:// studyinthestates.dhs.gov/515a.

#### DHS Proposes Work Authorization for H-4 Dependents

On May 11, 2014, the Department of Homeland Security (DHS) U.S. Citizenship and Immigration Services proposed a rule that would allow certain H-4 dependent spouses of H-1B nonimmigrants to apply for work authorization. Under the proposition the availability of work authorization would be limited to H-4 dependent spouses of principal H-1B nonimmigrants who are in the process of seeking lawful permanent resident status through employment; specifically, those whose H-1B spouses are either the beneficiaries of an approved Immigrant Petition for Alien Worker (Form I-140) or who have been granted an extension of their authorized period of admission in the United States beyond six years

under the American Competitiveness in the Twenty-first Century Act of 2000 (AC21). So, effectively, this would allow H 4 spouses to apply for work authorization in the following situations:

- Those whose spouse has a labor certification or employer petition (I 140) which is over 365 days old, and the H1B spouse has obtained an extension of H status as a result;
- Those whose spouse has an approved employer petition, but is in a backlogged category (generally, those in the EB 3 preference, and EB 2's born in China or India whose spouse is also born in one of those places; and
- Those whose spouse has an approved employer petition that is not in a backlogged category, but who is not able to obtain work authorization through concurrent filing of an application for adjustment of status (I 485). For example, the I 485 was denied, or the spouse is simply unable to file for any reason.

The rule is subject to public comment prior to July 11, 2014. After that time DHS will consider making revisions to the rule before it is finalized and becomes effective, likely sometime in 2015, but there is no guaranteed timeframe.

The rule recognizes that the lack of employment authorization for H-4 dependent spouses often gives rise to personal and economic hardship for the families of H-1B nonimmigrants the longer they remain in

the United States. It is a move to facilitate the retention of highly educated and highly skilled nonimmigrant workers in the United States by U.S. employers. "In this rule, DHS is proposing to extend employment authorization to certain H-4 dependent spouses of H-1B nonimmigrants. DHS believes that this proposal would further encourage H-1B skilled workers to remain in the United States, continue contributing to the U.S. economy, and not abandon their efforts to become lawful permanent residents, to the detriment of their U.S. employer, because their H-4 nonimmigrant spouses are unable to obtain work authorization."

#### DV-2015 Diversity Visa Lottery Winners Must File Electronic Application

The Department of State recently announced that beginning with DV-2015, all diversity visa (DV) applicants must submit the electronic DS-260 "Immigrant Visa and Alien Registration Application". The DS-260 will be ready for applicants to use on May 19. According to the announcement, the Kentucky Consular Center (KCC) will no longer collect the DS-230 and DSP-122, and no physical file will be sent to the consular post. Applicants for DV-2014 will continue to use the DS-230 and DSP-122. This is in keeping with a move last year to move all immigrant visa applications to the online "paperless" application and processing.

Effective May 1, DV-2015 applicants who view their selection notification online at the Entrant Status Check (ESC) website will be directed to <u>travel.state.gov</u>. The instructions for the visa application will tell them to fill out the DS-260 application, which will be available beginning May 19, in CEAC. To log into CEAC, DV-2015 applicants will need to provide their DV case number as given on their selection notification and the principal applicant's date of birth.

#### CBP Announces New Website for I -94 and Travel History

May 1, 2014, U.S. Customs and Border Protection (CBP) recently launched a new website that will allow nonimmigrants to access their I-94 arrival/departure record for any point within the past five years. Applicants were previously required to submit Freedom of Information Act Requests (FOIA) to obtain the information, which typically led to lengthy delays. According to the announcement, when visiting <a href="http://www.cbp.gov/travel/">http://www.cbp.gov/travel/</a> international-visitors/i-94instructions, nonimmigrants can retrieve their I-94 arrival/ departure record numbers and five-year travel histories by entering their names, dates of birth, and passport information. Clicking on "Get Travel History" will return a five-year travel history based on the I-94 records, which can be printed. Clicking on "Get Most Recent I-94" will return the I-94 number, most recent date of entry, class of admission and admituntil date. The system does not reflect changes of status, extension of stay or adjustments of status granted by U.S. Citizenship and Immigration Services.

#### DHS Report on International Students Studying in USA

The Student and Exchange Visitor Program (SEVP), part of U.S. Immigration and Customs Enforcement's (ICE) Homeland Security Investigations (HSI), recently released "SEVIS by the Numbers," a quarterly report of international students studying in the United States. According to the report, as of April 1, almost 1.02 million international students were enrolled in nearly 9,000 U.S. schools using an F (academic) or M (vocational) visa. Seventy-five percent of all international students were from Asia, with 29 percent from China. Saudi Arabia and India had the greatest percentage increase of students studying in the United States at 10 and eight percent, respectively, when compared to January statistics. The top 10 countries of citizenship for inter-

national students included: China, India, South Korea, Saudi Arabia, Canada, Japan, Taiwan, Vietnam, Mexico and Brazil.

The April report also included key insight into which international students pursue STEM (Science, Technology, Engineering and Mathematics) coursework. Sixty-seven percent of international students studying STEM fields were male. Forty-three percent of all international STEM students studied engineering. Seventy-eight percent of international students from India Studied STEM fields, while only eight percent of international students from Japan studied STEM fields.

Other key points from the report include: 77 percent of SEVP-certified schools had between zero and 50 international students; 72 percent of international students were enrolled in bachelor's, master's or doctoral programs; and California, New York and Florida had the most SEVP-certified schools. A school must be SEVP-certified before it can enroll international students.

# Chile Designated for the Visa Waiver Program

Effective March 31, 2014, Chilean citizens and nationals may enter the United States under the visa waiver program. Eligible citizens, nationals and passport holders from designated Visa Waiver Program countries may apply for admission to the United States at U.S. ports of entry as nonimmigrant aliens for a period of ninety days or less for business or pleasure without first obtaining a nonimmigrant visa, provided that they are otherwise eligible for admission under applicable statutory and regulatory requirements, and they generally waive rights to extend or change status, and to removal proceedings.

#### USCIS Changes Medical Exam Policy

As of June 1, 2014, any medicals filed with U.S. Citizenship and Immigration applications over one year ago have expired. USCIS recently announced that it will limit the validity period for all Forms I-693, Report of Medical Examination and Vaccination Record, to one year from the date of submission to USCIS. Applicants must also submit Form I-693 to USCIS within one year of the immigration medical examination.

USCIS will provide additional ways to submit Form I-693. This means that medical exams will no longer be considered "initial evidence" for processing of adjustment applications and applicants will likely be able to submit medical exams at adjustment interviews in some cases. Those who have pending applications with medical exams that will expire under the new policy will receive requests for evidence to complete a new medical exam before adjudication can be completed. This will impact people with applications whose priority dates have retrogressed and whose applications have therefore been pending more than 1 year with USCIS.

Those who will be filing an application for adjustment of status in the near future should consult with an attorney to determine the best strategy. If the visa numbers for your category are likely to retrogress, it may be best to delay the submission of medicals.

#### Pentagon Plan to Grant Citizenship to DREAMers Delayed

According to report in the New York Times this week, a Pentagon plan to extend a path to citizenship for some DREAMers has been delayed. The MAVNI program allows certain foreign nationals who are lawfully present in the U.S. to enlist in the U.S. military in exchange for many benefits, including naturalization. The program is open to people who meet limited criteria, can pass a strict background check, and who have special medical or language skills that are needed by the U.S. military. The extension of MAVNI to certain DREAMer's, or people who have been granted deferred action for childhood arrivals (DACA), has been delayed by President Obama to allow House Republicans to take action on immigration legislation during the summer session. We have reported extensively on the MAVNI program in the past.

#### New Immigration Policy Helps Families of Military Veterans: PIP

On November 15, 2013 USCIS released a memorandum detailing a program that benefits active military, reservists, and veterans. Parole-in-Place allows an individual who entered the U.S. without authorization to remain in the U.S. and apply for his or her green card without being required to travel outside the U.S., submit special waivers, or endure long periods of separation from family.

#### MAVNI Program Expanded to Include Reserve Components

In a December 13, 2013 letter the Department of Defense (DoD) agreed to expand the Military Accessions Vital to the National Interest (MAVNI) Program to include Reserve Components on a case-by-case basis. The authorization specifically allows up to 100 additional Army Reserve recruits who possess specific critical language skills. MAVNI allows noncitizens with degrees in certain health care fields, or those with particular language skills, who have been legally present in the United States for at least two years to join the US Army, Navy,

Marine Corps or Air Force and apply immediately for U.S. citizenship without first obtaining lawful permanent residence. To be eligible for the program, applicants must have been legally present in the U.S. for at least two years and possess the skilled medical training or language skills the DoD has designated as in demand. Those who are out of status or undocumented, visitors on B visas or the Visa Waiver Program, as well as those with serious criminal records, are ineligible for the program. Those who previously maintained H status and fell out of status after filing an application for adjustment of status may be allowed to participate on a case-by -case basis. Applicants in nonimmigrant status must not have a single absence of more than 90 days in the two year period prior to applying for the program. Through the military naturalization process applicants pay no fees for the application, but do have a contractual obligation to serve in the military for a minimum of four years active duty for language recruits, or a choice of three years active duty or six years Select Reserve for medical recruits. In either case, a recruit has an eight year contractual commitment to the military, including non-active service, and citizenship can be revoked if an applicant does not provide at least five years of honorable service.

This program could help many people with limited immigration options, including J-1 physicians who have been in the U.S. for two years and have a U.S. medical license, but are subject to the two-year home residence requirement. Such physicians could naturalize without completing the home residence requirement nor requesting a waiver. Nurses could also benefit when they might otherwise have difficulty obtaining appropriate work visas. Those in TPS, U or T status for at least two years could also enlist and naturalize when they might otherwise have very limited immigration options.

#### DOL Releases Surprising Internal Audit Guidelines

The Department of Labor Atlanta National Processing Center (NPC) recently released internal guidelines used to determine which labor certification cases should be subjected to audits and possible supervised recruitment. A DOL "audit" of a PERM labor certification means that the Department wants to examine the actual documents that back up the employer attestations under oath on either the electronic or paper version of Form ETA 9089. "Supervised recruitment" means that the Department feels that the job in question has not been adequately recruited, and orders new recruitment, with responses routed through its office in Atlanta.

The enumerated audit and supervised recruitment triggers include: Jobs for which the primary requirements are less than

Bachelor's Degree, Trade related occupations, Certain public schools, Cases that require a degree and no experience, Some cases where the employer indicates on the labor certification form that it has recently had a layoff, Applications by same employer and employee that are resubmitted after denial within the calendar year, Applications by same employer and employee that are resubmitted after withdrawal of an audit case within a calendar year, Applications which are filed on paper, rather than electronically.

Notably, the DOL also indicated that several audit triggers are not currently active, meaning these characteristics should not trigger audits but previously may have. Those inactive triggers include: H-1B Dependent Employers (employers who have large numbers of H1B temporary workers as a proportion of their overall workforce) Jobs requiring a degree where the employee entered the US with no papers or with an H2 (skilled worker or agricultural worker) visa, Employers who recently issued layoffs (only SOME of these cases are now audited), Employers with a history of roving employees (employees with no fixed worksite).

Note that despite this helpful list, the vast, vast majority of DOL audits are totally random, and usually have nothing to do with an audit "trigger" or any mistake on the application. It should also be noted that we have filed many cases which might fit within one or more of the foregoing audit "triggers," which were never audited. So, in the final analysis, despite these new revelations, one never knows exactly what will happen when filing a labor certification!

#### If Barbaricum Calls, Don't Panic!

On February 10, USCIS announced that it hired Barbaricum, a professional research group with a very strange name, to conduct phone and email surveys with USCIS "customers". If you receive an email or phone call from Barbaricum regarding your experiences with USCIS, feel free to answer the survey or decline, whatever your preference. USCIS hopes the information will be helpful in improving customer service in the future. To see more visit the USCIS website.

#### DOS Announces J-1 On-Site Inspections

The Department of State recently emailed J-1 exchange visitor sponsors to announce that it plans to conduct onsite inspections of J-1 internships and training programs. The visits will be both planned and unannounced. J -1 inspectors may want to speak with responsible officers, supervisors, employees, trainees, and interns, and to inspect facilities, housing, and health insurance arrangements. Inspectors also may review signed Forms DS-7002, Training/Internship Placement Plan, for interns or trainees.

# Temporary Protected Status ("TPS")

TPS is a temporary immigration benefit that allows qualified individuals from designated countries who are in the US to stay here for a limited time period. A country may be designated for TPS based on certain conditions in the country that temporarily prevent the country's nationals from being able to return safely, or in certain circumstances, the country's government from being able to handle their return adequately. A TPS country designation may be based on on-going armed conflict, environmental disaster, or other extraordinary and temporary conditions in the country. In general, eligibility for TPS requires demonstrating one is a national of a designated country, was physically present in the US on a certain date, has maintained continuous residence in the US, and has timely registered for the benefit.

On March 3, 2014, the Secretary of Homeland Security extended the designation of Haiti for TPS for a period of 18 months. (DHS) established a 60-day reregistration period from March 3, 2014 through May 2, 2014. DHS has decided to extend the reregistration period through July 22, 2014 to allow more time for those who are eligible to reregister.

Haitian nationals who have previously been approved for TPS must apply for the extension before July 22, 2014. USCIS has automatically extended the validity of employ-

ment authorization documents issued under the last extension/ designation of TPS Haiti for an additional 6 months, through January 22, 2015. If you have a TPS Haiti EAD with an original expiration date of July 22, 2014, you are covered by this automatic extension and may continue to work. Haitians who have not

previously held TPS may be eligible for late registration in limited circumstances provided they meet all other eligibility requirements. Visit the USCIS for more information.

The TPS statute explicitly provides that a non-immigrant alien is not required to relinquish status to obtain TPS and that TPS is not inconsistent with the granting of non-immigrant status. Thus, obtaining TPS may be a good idea as a back-up plan, but it is also wise for an individual to maintain non-immigrant status as long as possible as well. However, if an individual has both TPS and a nonimmigrant status, travel outside of the US may jeopardize TPS status.

## Community College (CC) Update — Cliff Thompson

Greetings from the Region III Community College Representative. Community Colleges were well represented at the NAFSA Region III conference in Rogers, AR in October of 2013. Many thanks to our partners from Northwest Arkansas Community College who organized the community college reception and conducted a great session at the conference. At the conference we offered two sessions regarding community colleges. One was on internationalization of the community college campus hosted by NWA Community College and the other was on the top five challenges community college international educators face hosted by North Lake College with a panel discussion of community college international educators from different campuses across the region.

At least one of the sessions was attended by representatives from NAFSA national which was great as the representative from the NAFSA national office took notes and



spoke briefly at one of the sessions. A November 22, 2013 NAFSA webinar on community college internationalization was announced encouraging communi-

ty college international educators to attend the November 22 webinar. I along with a group of other community college international educators attended that November 22, 2013 webinar. Before the sessions we conducted in Rogers, I had the opportunity to speak with representatives from the national office on how community colleges are underrepresented and what we are doing to increase representation in our profession. It was great to see representatives from the NAFSA national office come to one of the sessions.

During the sessions we did in Rogers we outlined what community college international educators can do to address the identified challenges and how community college international educators can work with their respective institutional administrators to get more support from their campus administrators to further internationalize campuses. The identified top challenges were gathered in survey results that were sent out before the Rogers conference. The results obtained were presented in one of the sessions. The sessions became a great forum for discussions providing information to attendees on what they can do over the next year to address the challenges we face as community college international educators in finding creative solutions.

In conclusion, I look forward to the next regional conference as we seek to represent ourselves well in Fort Worth, Texas this November 2014.

# Intensive English Programs (IEP) Update — Mark Powell

The NAFSA Conference in San Diego had a number of session devoted to IEP's and their role in international education. One theme that was mentioned at many of the IEP session was regarding bridge or pathway programs. As many of us know, there are a growing number of private, for-profit companies that are developing partnerships with existing IEP's at many different universities to create bridge or pathway programs. At the IEP MIG meeting, a panel of representatives from three different programs included Pace University, which has signed an agreement with Kaplan to create a Global Pathways program. Inside Higher Ed also posted an article about the growth of these public/private partnerships in April (http://www.insidehighered.com/ news/2014/04/30/look-landscapepathway-programs-internationalstudents-run-cooperationprofit#sthash.dyo2GdL4.dpbs). The IEP SEVIS Hot Topics

session produced some possible changes that would help IEP's. We are awaiting SEVP's release of Final Guidance regarding F-2 students' ability to study part time. SEVP will be issuing draft guidance on a number of topics related to IEP's, including a second round of draft guidance regarding bridge/ pathway programs, change of ownership of IEP's, and a comprehensive review of guidance regarding student employment. Interim Final Guidance regarding temporary absence and annual vacation are expected within the next couple months. The State Department indicated that its Interview Waiver Pilot Program is now available in several consulates around the world. Check on the Consulate's website to see if they are participating in this new program and what the requirements are to renew the F-1 visa. It allows current F-1 students to renew their F-1 visa without an interview at the U.S. Consulate.

In San Diego, many IEP's talked about the influx of Brazilians students on the Brazil Scientific Mobility Program (BSMP). At



the University of New Orleans, we will have a total of almost 45 studying English with us by the end of the summer. They will then hopefully transition to UNO for the Fall 2014 semester. We have enjoyed working with the students studying with us. Working with their sponsor, IIE, has had its bumps, however, it's been a learning process for both us and them. I plan on submitting a proposal for the **Regional Conference in Fort Worth** on working with sponsored students (specifically BSMP and SACM students) and helping them make the transition from IEP to university. ## Arkansas Update — Karl Anderson

The past year has indeed been a busy one for our state and its many dedicated NAFSA members. Definite highlights were hosting the Region III conference in Rogers last October as well as a very successful state meeting held at Northwest Arkansas Community College this past April.

The state meeting was held on April 11<sup>th</sup> and drew 54 individuals from 10 institutions across the state to Bentonville, Arkansas. Sean Kelley from the U.S. Export Assistance Center in Little Rock provided the opening presentation on how institutions can utilize the Gold Key Service in their recruitment efforts as well as other initiatives aimed at internationalizing their campuses.
