The website is divided up into three different spaces: Communities, Member Directory, and NAFSA resources. The Communities section has your own personalized community spaces. There are 11 total professional networks, which consist of email lists where NAFSAn's can submit questions and gueries. The networks are related to the 5 main KC groups. In addition to the professional networks, there are also private networks for the different Region Chairstreams and Teams as well as the many different NAFSA Committees. If you are a member of Trainer Corps, there's also a private community for Trainer Corps members. Each of the Member Interest Groups or MIG's has

its own community as well. All of these communities allow members to communicate freely with colleagues from their respective fields, teams and interest groups.

The Member Directory allows you to search the NAFSA Membership Directory. The Basic Search lets you search by name, institution or email address. The Advanced Search broadens the ability to search by city, state, and country as well as by professional, private and interest group communities and region. These search options come in handy when you are trying to locate a colleague's contact information. The third and final section is the NAFSA Resources page.

Each of the 5 KCs has a links to various resources. The resources

sources are further subdivided by each of the professional networks within each KC. This is a great location to start from when you are looking for any of the many resources NAFSA has created for

Greetings from the state of **OKLAHOMA!** Your colleagues from Oklahoma are looking forward to your visit October 19-22, 2015. This is your opportunity to explore Oklahoma. You can experience a Western adventure, outdoor experiences such as stunning state parks, vibrant American Indian culture, and the colorful Route 66. Norman is the third -largest city in Oklahoma and offers a college town atmosphere with excellent restaurants, and the Sam Noble Oklahoma Natural History Museum. Sam Noble Oklahoma Museum of Natural History will be our off-site event with a theme "Night at the Museum". The museum is the nation's largest

university-based museum, with dinosaurs that will amaze the visitors (<u>http://</u>

samnoblemuseum.ou.edu/). The museum has 50,000 square feet of exhibit space and 500 million years of Oklahoma Natural & Cultural history. The Hall of People of Oklahoma exhibits the earliest archaeological evidence of humans in Oklahoma and follows through time of what it means to be Native American.

Other possibilities to visit are The Fred Jones Jr. Museum of Art with world-renowned works of Monet, Renoir and Van Gogh. The Riverwind Casino is located on Highway 9 a short distance from the hotel. The casino has 219,000 square feet of electronic games, table games and gambling favorites. Registra-

## Development in the Time of Ebola - John Singleton

It is a strange time to be working in International Education. While the recent past—the politics of post-9/11 and the post-economic cutbacks of 2008 are thankfully a wonderful memory—developments on many fronts suggest our work and our field is in a state of change. Even as the crisis in West Africa has quietly left the pages of our headlines, there is much to consider.

Technology has delivered on a promise no one (well, few) saw, as the developing world has been brought in color into our living rooms, and our lives and academic institutions have been "smart-phoned" into theirs. The rise and existence of the "refugee state" has strained governments and organizations worldwideongoing conflicts in Central Africa, Syria, Afghanistan and Pakistan, the Middle East and not to forget the Americas have created a community in transit, and a very desperate one. And growing cynicism and nationalism has created a kickback against NGO's and refugee presence which has begun to slip over into broader questions of "international students" and "education abroad. It seems a great distance across a cloudy horizon from how we should go about the affairs of Region III and International Education, but I want to draw the reference as I think it matters here, just as I think you and I matter in the dialogue. In the "tipping point" Malcom Gladwell reminds us that it is not one great thing but a groundswell of smaller things that lead to impacts—both positive and calamitous, I would add. Advanced development is not the ability to raise funding but to raise awareness, with the assumption that other forms of support-monetary, yes, but political, access-based, and openness, too—will follow. In the wake of 9/11, those of you who were working in the field will remember that many of our offices went from "anonymous" to "visible" overnight. Within a few months, the Department of State ensured it by reaching out not to



tees, reminding them of the "patriotic" obligation to support proposals that would impact our work in very significant ways. Once we had survived the first few weeks of "deport'em-all" there was a period of calm that looked (from my view) like a profession realizing the importance of its global work.

In that wake, IIE, NAFSA, AIEA, ACE and many others realized for us—and it was for us because at the grassroots level we were still not recognizing both the problem and the potential—the need of solid ambassadorial work in the trenches where decisions were made. That work would pay for itself over and over again as global issues have often served not to shut down our jobs but as catalysts linking the academy to a deeper consideration of the "...Malcom Gladwell reminds us that it is not one great thing but a groundswell of smaller things that lead to impacts..."

issues that create these problems to begin with. The enrollment of Saudi students at US schools, Girl Power, Inc., and the movement to educate young women, and the engagement around the world of educational institutions with NGO's doing invisible but courageous jobs in Health, Education, Human Trafficking are some easy examples. The obvious truth is that good developmental work-starting with your role in educating leadership in our institutions, community organizations and local political bodies-can leverage our connectedness across international education and transform events into positive outcomes. In this way, events like the Ebola crisis become real-time educational

outcomes, outcomes in which our jobs and our students' learning curves are secondary to human lives being transformed and saved, and invisible communities (often composed of refugees and people who don't even show up on the poverty scale) becoming a part of our student's educational experience. This final outcome-when our institutions adapt so that those studying the Ebola crisis or rape as a systemic tool of terror are from the places where these events are playing out-will truly transform our institutions and the world. They will help us realize our connectedness, and in some way that is all development isconnectedness. Yet the opposite is possible,

too. Yesterday my colleague issued our first "stateless" I-20, to a young woman who is a refugee from one of the aforementioned crises. No citizenship, no geographic memory of family, just a tent and some brave NGO willing to provide education in that circumstance. Without your good leadership, the advocacy and development that allowed her to apply for a visa would not have been possible. And those who would stop it are very organized, too. Yes, we need funding and financial support, too, but as a friend on a dusty bus-ride outside Kigali told me yesterday, don't forget the heart when you're making your case for development.

#### Conference Immigration Highlights

The NAFSA Annual Conference was held in Boston this year and I think we can all agree that it was packed with great immigration updates and information. With last minute attendance from several government officials and streaming video chats, we received updates on various topics from USCIS, SEVP, and CBP. #### <u>Annual\_Conference/</u>. SEVIS Update

The SEVIS Release 6.21 is scheduled for 6/26/2015. This is the largest update we've seen in years. SEVIS will be down for a minimum of 48 hours during this release. This update includes name and email standardization, revised Form I-20s and Form DS-2019s, as well as additional functionality. This update will affect other systems such as the I-901 System, SAVE, and E-Verify while SEVIS is down. You can read more about the recent updates for SEVIS at study-

Final Rule Effective May 29, 2015 Eliminating DSO Limits and Allowing Part-Time

**F-2 and M-2 Study** Effective May 29, 2015, there is no longer a limit on the number of DSOs as they see fit. DSOs will still need to be nominated through an I-17 update. SEVP is requesting that all additional DSO requests be made after the SEVIS upgrade at the end of June.

Also under the final rule, F-2 and M-2 spouses and children will be allowed to enroll in part -time study. Pursuing a full course of study and engaging in employment are still considered violations of status for F-2 and M-2 visa holders. This rule does not affect the previous regulations on avocational and recreational studies.

**Optional Practical Training** Please remember that under 8 C.F.R. § 214.2(f)(11)(i)(B)(2), Form I-765 and I-20 with an

OPT recommendation must be submitted within 30 days after the DSO updates SEVIS with the recommendation. USCIS Service Centers will deny or issue Requests for Evidence (RFE) based on this 30 day deadline. If a student receives an RFE for this reason, it is best practice to cancel the OPT request in SEVIS and create a new request before mailing the new I-20 promptly.

USCIS also emphasized the necessity of including proof of all previous CPT in OPT Applications. CPT can be indicated through copies of all previous I-20s or if all previous I-20s cannot be located, a SEVIS screenshot of the student's history of CPT provided by the DSO

should be sufficient. Please note that if students choose to e-file their 1-765, biometrics will be required. If there is a clear adjudication error when filing an 1-765 with USCIS, you can contact your Regulatory Ombudsman, Amanda Brinlee, through IssueNet to have the case addressed.

Many students are now requesting their OPT applications to be expedited. Students must be able to prove that they fit the expedition criteria as a result of their application not being approved quickly. A list of the criteria can be found on the USCIS website at



www.uscis.gov. Students must first contact the National Customer Service Center at I-800-375-5283.

#### **ELIS Updates**

The Electronic Immigration System (ELIS) has been active for over three years now. However, as of this newsletter, there is limited availability for the electronic filing of Form I-539. Students will need to submit paper I-539 applications to the appropriate service center. #### online-filing. Travel Information

There has been a mass system fail of consular visa issuing processes. This system failure has impacted visa appointments worldwide. Please have your students and scholars verify their visa appointments over the summer so as not to impact their international travel plans or ability to return in time to continue their program. As a reminder, it is important that students and scholars receive valid travel signatures on their I-20s and "Please note that if students choose to e-file their I-765, biometrics will be required."

DS-2019s before attempting to re-enter the country. If a student or scholar attempts to reenter the United States without the appropriate travel signature or documentation, it is still procedure that CBP admit the student for 30 days and issue an I515A. It will be up to the DSO or A/RO to assist the student with the I515A. For more information on form I515A, visit http://

#### Temporary Protected Status ("TPS") –

TPS is a temporary immigration benefit that allows qualified individuals from designated countries who are in the US to stay here for a limited time period. A country may be designated for TPS based on certain conditions in the country that temporarily prevent the country's nationals from being able to return safely, or in certain circumstances, the country's government from being able to handle their return adequately. A TPS country designation may be based on on-going armed conflict, environmental disaster, or other extraordinary and temporary conditions in the country. In general, eligibility for TPS requires demonstrating one is a national of a designated country, was physically present in the US on a certain date, has maintained continuous residence in the US, and has timely registered for the benefit. A number of countries, such as El Salvador, Nicaragua Honduras, Haiti and Sudan, have been designated for TPS over the years and are in extension periods. TPS was recently designated for Liberia, Guinea, and Sierra Leone and the registra-

tion period closed in May. TPS was extended and **redes**- **ignated for Syria**. An applicant must demonstrate that she/he was in the US on January 5, 2015 and present since April 1, 2015. The applicant must apply for TPS before July 6th, 2015.

On June 24th, 2015, DHS announced that **Nepal will be designated for TPS as well**. As of the writing of this article the dates for registration have not yet been published, but plan on registration closing in mid-December.

The TPS statute explicitly provides that a non-immigrant alien is not required to relinquish status to obtain TPS and that TPS is not inconsistent with the granting of nonimmigrant status. Thus, obtaining TPS may be a good idea as a back-up plan, but it is also wise for an individual to maintain non-immigrant status as long as possible as well. However, if an individual has both TPS and a non-immigrant status, travel outside of the US may jeopardize TPS status.

#### Work Authorization for H-4 Dependents

The long awaited work authorization for H-4 dependent spouses has finally arrived with great limitations. Now, an H-4 spouse can obtain work authorization if the H-IB principal spouse:

- Has an approved I-140
   petition; or
- Is an H-1B status based on a provision of AC 21 (in other words, is past the sixth year of H-1B status).

An individual who wishes to obtain work authorization as an H-4, will file form I-765 with the necessary supporting documents and filing fee. Full instructions and the form are available at http://

#### www.uscis.gov/i-765. Simeo Solutions – Changing work locations for H-IB employees

#### On April 9th, 2015, USCIS' Administrative Appeal Office (AAO) issued a precedent decision, Matter of Simeio Solutions, LLC, which held that employers must file amended H -IB petitions when a new Labor Condition Application for Nonimmigrant Workers (LCA) is required due to a change in the H-IB worker's worksite location. The AAO found that if an H-IB employee changes location that requires a new LCA that change constitutes a material change in the employment and an amended H-IB is required. USCIS is currently drafting guidance implementing this decision. The draft guidance is available for review at http://www.uscis.gov/news/ alerts/uscis-draft-guidancewhen-file-amended-h-lbpetition-after-simeio-solutions-

<u>decision</u>. In summary, the draft guidance states that an amended petition must be filed when the H-IB employee moves to a worksite location outside of the metropolitan statistical area or the area of intended employment covered by the existing petition. Certain short term placements do not require an amended petition. An amended petition does not need to be filed when the new location is within the same metropolitan statistical area or within the scope of the original petition. Once an amended petition is filed, the H-IB employee can immediately begin work at the

#### new location.

If H-1B employees were changing locations at the time of the Simeio Solutions decision, an employer has until August 19th, 2015 to file amended petitions. If H-1B employees changed location before the decision, USCIS will not take adverse action, but employers must now file an amended petition for these H-1B employees by August 19th, 2015.




