SEVIS II

- "Previsualiation" ended in April 2011
- Now in "Visualization" phase
- IOC now "unofficially" projected for November 2013
- SEVIS II Transition conference beng held in Washington, DC August 1-5, 2011
 - Invitations went to specific schools in order to have a cross-section of all types and geographic locations
 - Spots not filled by invitees may be re-allocated to others who request invitation
 - SEVP covers travel and associated costs

SEVIS II (cont.)

- Expanded record correction options
- DSO can generate Help Desk ticket within SEVIS
- Can enter—and then search by—campus ID numbers
- No paper to carry through POE
- No more I-515
- Will rely on “Red light, Yellow light, Green light” admissibility indicators
- Students still enter own basic biographical information
- Errors can be corrected at consulates
 - DSO/ARO receives notification of any corrections made
- DSO/ARO may also request a correction to student biographical information
 - Unclear how this would specifically

SEVIS II (cont.)

- SEVIS II will have ability to notify students of changes in record and approaching critical deadlines by email or text
- Ability to report students who are ABD
 - Optional but not required
- Expanded program and financial information from I-17
- Joint agency policy on naming conventions coming out "soon"

J-1 Functionality

- 212(e) indicators within the record
 - Will take into account funding sources and Skills List
 - Will include waiver indicators
- EV can request actions/benefits through SEVIS*
- May create templates for record creation*

**Not clear if this will apply to F-1 records as well)*

USCIS Transformation

USCIS is transitioning to electronic filing

- Agency wide (eventually)
- Adjudication will still take place at service centers with same geographic jurisdictions
- Optional-may still file using paper applications for now
- Lockboxes will continue to operate

USCIS Transformation (cont.)

- Users will be assigned an IIN
- May select form type from drop-down menu
- Only relevant fields will appear in user interface

USCIS Transformation (cont.)

- Supporting documents -- copies of I-20's, passports, I-94 cards, etc. – may be uploaded
- Documents uploaded for one application will be available for all applications filed by same individual based on IIN
- May return to account to change information

USCIS Transformation (cont.)

- One system for all involved—applicant, adjudicators, officers, etc.
- Attorneys may have own accounts (IIN-based) and clients will grant access through an electronic G-28
- Universities will have organizational accounts to facilitate assistance with student and scholar applications

USCIS Transformation (cont.)

- Payment mechanism being designed to accept credit card payments and electronic checks/ACH
- Being implemented in 3 phases
 - Phase I: December 2011; I-539
 - Phase II: July 2012; I-765 + other forms
 - Phase III: Date TBD; forms TBD

Advisor's Manual 2.0

- “Soft release” on Friday evening, May 27
 - Basically a “live beta test” so still working through a few login and accessibility issues
- New server
- Opens live, so no loading/waiting
- Chapters and sections printable and convertible to pdf
- Can email sections to other subscribers from within manual

Advisor's Manual 2.0 (cont.)

- Improved search function
- Notes
 - Individual notes
 - Group notes
- Licenses transferrable
- Can set home page
- Bookmarks

J-1 Updates

- Exchange Visitor Program has a new web site:
J1visa.state.gov
 - Regulations, plain-language resources for EV's, potential EV's, sponsors, hosts, etc.
- Subpart A revisions are expected prior to SEVIS II IOC
- Subpart A revisions will therefore not incorporate SEVIS II provisions
 - \$2700 fee for designation/re-designation
 - \$233 fee for reinstatement

J-1 Updates

- EVP has conducted 21 site visits so far; concerns include
 - Inappropriate use of categories
 - Failure to update addresses
- Next set of site visits likely late fall 2011 or early 2012

H-1B Updates

- USCIS currently processing cap exempt cases received 04.08.2011
- Cap Update:
 - 13,000 cap-subject petitions
 - 9,000 master's degree & higher petitions
- SCOPS reports RFE templates are being standardized – hope for more consistency!
- PWD issues – some inconsistencies with codes, wage levels, etc.
 - Report issues in IssueNet

Other Updates

- NSEERS ended as of April 28, 2011
- SSR now available for Libyans who were legally present in the US on February 1, 2011
 - ESL students are eligible
