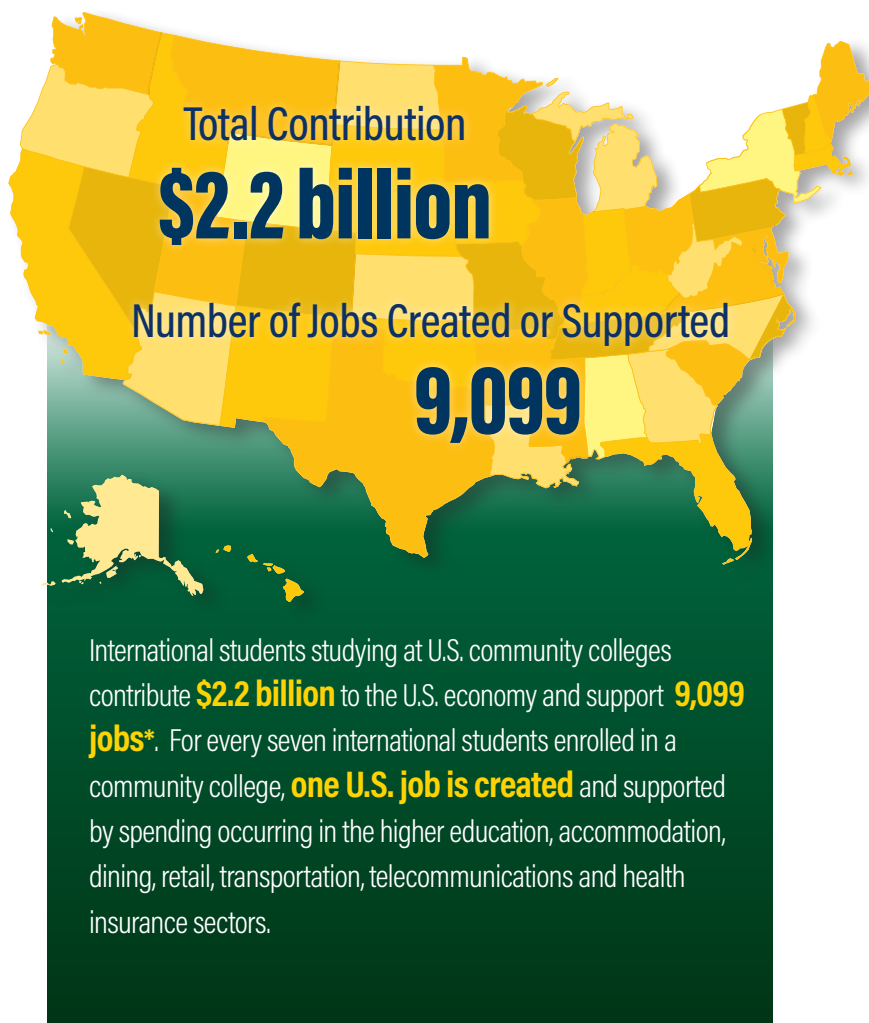


Economic Value of International Students at U.S. COMMUNITY COLLEGES
