It presents information on the numbers overall in the US, in Region I, the schools responding to the survey, most frequent academic areas represented, and then details impacts on individual advisors and campuses. This session will focus on self-sponsorship options for Postdocs and will provide specific pointers on enhancing their cases for permanent residence.
