

J-1 Issues

- EVP two month extension
- EVP outreach
- Guidance for Incorrect issuance of \$1200 funds
- Initial document Issues uncertainty of summer/fall travel and program start dates
- Consular closure issues



H-1B issues

- Suspension of Premium Processing
- Limited Expedite Option for Doctors, Medical Researchers, COVID-19 related employees
- More scholars switching to this option Could be FT or PT (flexibility)
- Copies of documentation & electronic signatures being temporarily accepted
- Issues with biometric appointments for Forms I-539/I-539A being submitted for families
- Consular Processing and applying for H-1B entry visas
- Cap-subject H-1B issues and the Cap Gap Extension

TN Issues

- Based on NAFTA treaty USMCA (new name)
- Specific occupations on the TN list
- Must have the appropriate training/degree/license and/or experience noted in the treaty
- CBP sometimes flexible with requirement
- Effect of closure of US-Canada border PFI or Border?



E-3 Issues

- H-1B lite
- Requires LCA
- Department of Labor requirements apply (Posting Notice, etc.)
- Easiest to apply for at the Australian Consulates
- Bypassing 212(e) prohibition



0-1 Issues



- The focus is on the applicant/beneficiary
- Must satisfy at least 3 of the listed requirements
- Must have a petitioner, contract, and itinerary (if applicable)
- For an initial period of up to 3 years, one year extension thereafter if with same employer/same project(s)
- Better option for J-1s subject to 212(e) that need to transition to another status (No COS)
